VICE PRESIDENT'S REPORT

To understand where you are going it's important to reflect on where you have come from, but you can't spend too much time looking in the rear view mirror. If you do that you will miss your destination...

The end of each playing year is the time to assess the previous twelve months, reflect on the areas of success—and those where further work is needed - and to plot the course towards the immediate future.

We can review 2022 with a degree of satisfaction in a number of areas while being aware that we are coming off some difficult times related to the Covid pandemic.

Our Strategic Plan, covering 2021-23, provided some direction for the Board of Management but also highlighted areas where work is required, for example in Marketing and Communication. This, plus continuing to develop participation strategies, and strengthening our organisational capacity and collaboration with stakeholders will need effort during 2023. We need to ensure that our sport remains relevant and visible. We want badminton to be the sport of choice across age groups, abilities, and ethnicity.

We maintained sound relationships with the Department of Sport Recreation and Cultural Industries (DLGSCI) and Healthway, our most significant funding partners, and we were heartened at the end of the year to know that the DLGSCI Governance (Organisational Sustainability Programme) Grant will be increased in 2023. We were able to procure a Badminton Australia Participation grant related to the national Shuttle Smash programme, which is aimed at children aged 6-12 years. In June we also received a Coach Mentoring grant from DLGSCI which enabled us to focus on the development and nurturing of beginning coaches. A small grant from the Federal Government Community Services branch was also obtained and this was used in our Inclusivity programme.

Membership: The pandemic brought about a situation where many clubs had diminished numbers of players regularly on court and naturally this was reflected in registered members. Finishing the year with 2111 members showed that we had returned to figures comparable with those from more than 5 years ago and this is obviously an area where work is required to ensure clubs realise the value of affiliation for their office bearers and also for their players.

Competitions: The full season of competitions is detailed later in this Report but overall the number of competitive players was very encouraging—in particular in the lower grades. At the national level congratulations go to XIANG LIN, our most successful player, who represented Australia at the Commonwealth Games. Our Para athlete programme continued to make slow growth. Regular inclusion in our tournaments, plus competing at national and international level has seen this small band of players make progress. Badminton WA made a successful bid for a Para International tournament and this significant event will be held in Mandurah during September/October 2023.

Western Australia is in a remote corner of the world—and we are a long way from the badminton action in that currently ALL the national events are held on the East Coast, the national high performance training centre is based on the east coast- and international events are currently happening on the east coast...all of which means our competitive players (plus their parents) and officials are faced with increasing costs in order to further their careers.

Development in the areas of Coaching and Technical Officials continued throughout 2022. WA is well represented nationally in these areas, as the reports show. Junior development continued through our well established WINGS groups, Sporting Schools programme and junior events.

VICE PRESIDENT'S REPORT

The year ended with an Awards Function being held at the Kingsway Function Centre, with the Badminton Australia CEO, Jamie Parsons, being the Guest of Honour. It was pleasing that a number of Life Members attended this event.

Service Awards were presented to: Christine Ferguson | Rita Bonjour | John Granville | Yuli Zheng, for significant service to Badminton WA.

WA Representative Badges were awarded to the twenty seven 'first time' State team players. Life Member and Patron, Kay Terry, presented the WA Player of the Year Award to Xiang Lin, while Patron, Gary Dymond, presented the WA Umpire of the Year Award to Lily Buttrose.

A change of staff occurred during the year. Administration Officer, Ashleigh Playle, left in May to take up a new position and in July Executive Officer, Rick Wolters, resigned and moved to the sport of Softball. We were able to welcome Sam Jones to the Administration Officer's position, (part-time) and in September Ghaz Ramli came on board as our Executive Officer. They both approached their work in an enthusiastic manner and by Christmas they had a good grasp of the range of tasks to be done. Ryan Lin continued as our Community Development Officer and was also invaluable in supporting our events. Our thanks go to Christine Ferguson who was our volunteer Acting Executive Officer for nine weeks, and our Staff for their contribution to the growth of our sport.

A major disappointment for 2022 was the deteriorating state of our finances. With the final accounting leaving us with a \$50,000+ deficit for our financial year the focus for 2023 must be to rein in costs, search for other income sources and to endeavour to bring us back to a more stable financial position as we go forward.

Special thanks must go to the Badminton WA Board of Management: Mark Cunningham, Christine Ferguson, Kim Rodgers, Lily Buttrose, Lisa Chapman and Judy Cowper. They are all volunteers who give up many hours of their time for the benefit of the badminton community. They are enthusiastic, purposeful, persistent, and handle their portfolios in a professional manner. As the Board of Management underpins the governance, the programmes, the projects and indeed the fabric of the Association the leadership provided, and work undertaken, by them is invaluable.

I recently read: We live in an era of withering institutions, ebbing volunteerism, and declining trust. In such an environment the levers of powers fall to the shrinking band of diehards... If badminton in WA is to flourish we need more people to provide support, ideas, allegiance, -- that is, make a contribution. There is little power to be had, plenty of work to do- but also a great sense of satisfaction in helping to promote and grow a sport that we all love. We need to foster a culture of willingness to participate, cooperate and initiate.

Badminton WA has the potential to make positive developments on many fronts but the future is in YOUR hands. I urge all members to work together to see new opportunities, new directions and new possibilities. Don't wait to be asked.

MEMBERSHIP REPORT

The Badminton Association of Western Australia (BAWA) witnessed a promising membership year in 2022, marked by significant developments and positive growth. This report aims to provide an overview of the membership trends and key observations during this period.

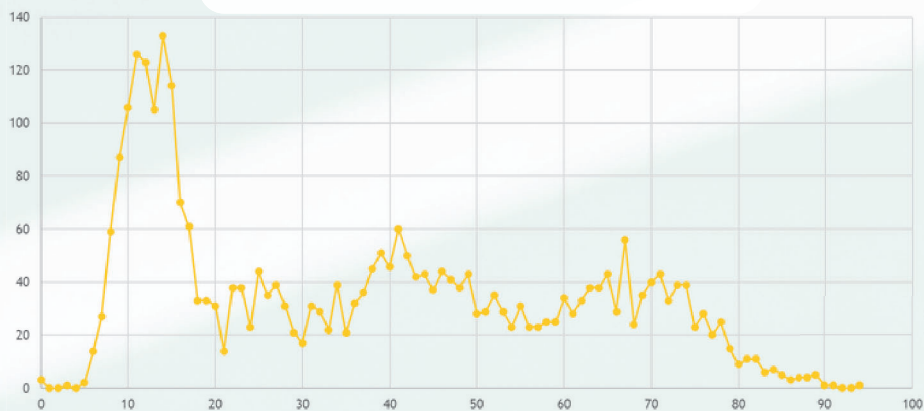

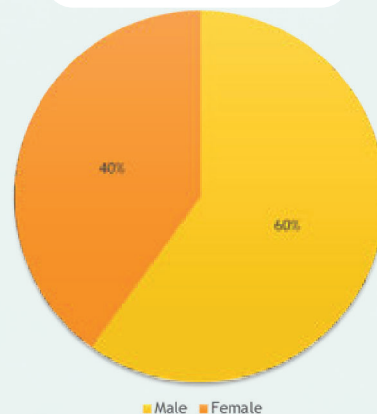


MEMBERSHIP DATA 2022

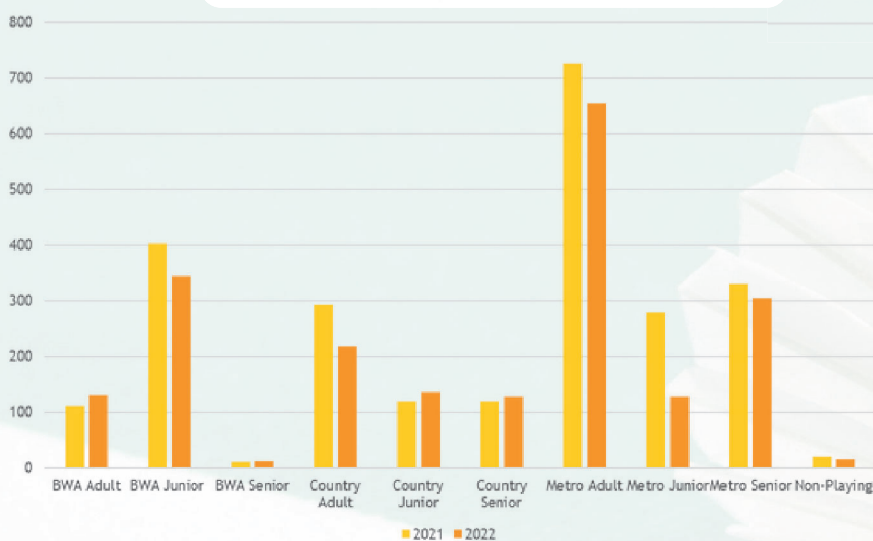
Number of members vs Age



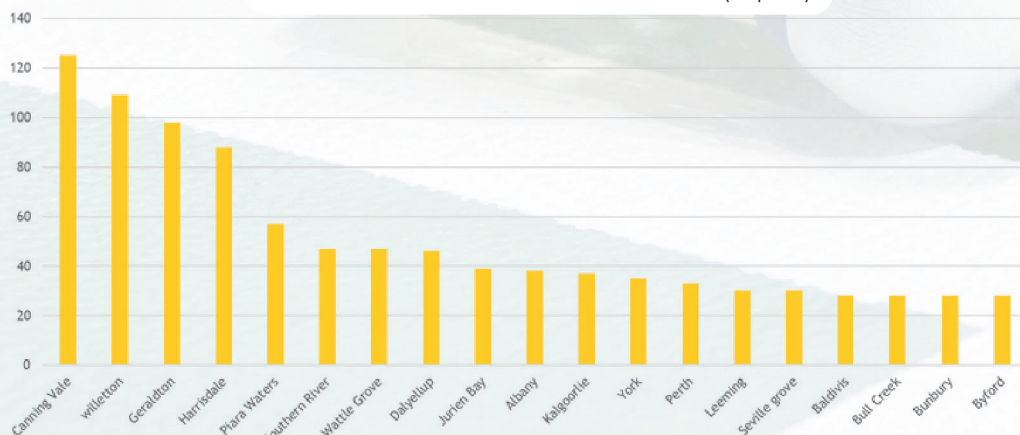
Member Gender

INCLUSION & PARA BADMINTON

It's been another busy year for Inclusion in WA. Locally, Para Badminton WA continues to run its inclusive program at Kingsway on Thursday nights. Mandurah Mixed Badminton Club also run their All Inclusive Badminton group on Monday nights in Mandurah.

Para Badminton WA has showcased para badminton at several Paralympic Multisport days and the Source Kids Expo for Telethon with Rebound WA. Also with Rebound WA, we have facilitated badminton sessions with their Whiz Kids Program (5-12 year olds) and Spinners program (teenagers).

WA players were nominated for several awards at Rebound WA's Annual Awards Breakfast. Caitlin Dransfield was nominated for Breakthrough Athlete of Year and the Frank Ponta Award (recognising a person who gives back to their sport), Grant Manzoney was also nominated for the Breakthrough Athlete of the Year Award and Mark Cunningham was nominated for Coach of the Year for this work coaching both Caitlin and Grant to the Paralympics in Tokyo. Caitlin came away with the Frank Ponta Award. Lochan Cowper was awarded the Oliver Foundation Scholarship.

BAWA is very pleased and proud to see our players recognised for their achievements.

Nationally, with COVID restrictions lifting, the National Para Badminton Championships and the Oceania Para Badminton Championships were held in Victoria in 2022.

Unfortunately, due to the cost of attending the Nationals, very few players outside of Victoria attended. Grant Manzoney was the only representative from WA. He successfully defended his WH2 singles title and retains his No. 1 Australian ranking.

At the 2022 Para Badminton Oceania Championships, Lochan Cowper and Grant Manzoney successfully defended their WH1 and WH2 singles titles. WA's Nang Van Nguyen was runner up to Lochan in the WH1 Men's Singles. Grant and Lochan also retained their Oceania WH1/2 Men's Doubles title. Grant also picked up Silver in the Mixed Doubles. Caitlin Dransfield came away Gold in the Women's SL4 Singles and Gold in the Mixed Doubles.

Internationally, the Para Badminton World Championships were held in November 2022 in Japan. WA's Lochan Cowper, Grant Manzoney and Caitlin Dransfield all qualified for this event and represented Badminton WA with pride.

With 2023 being a qualifying year for the Paralympics in Paris 2024, Lochan, Grant and Caitlin will all be attending as many international events as possible in the hope of making it to the Paralympics in 2024. BAWA is excited to be hosting the Oceania Para Badminton Championships and the West Australian Para Badminton International in Mandurah in October 2023.

The World Transplant Games are being held in Perth in April 2023. BAWA will be facilitating the badminton program for this event.

Badminton WA continues to support and promote inclusion in our sport and are constantly seeking ways to be more inclusive thus growing our player base.

TECHNICAL OFFICIALS REPORT

WA technical officials had a busy year with the state, national and international calendars full of events as the badminton world reopened after the disruptive effect of COVID-19 pandemic. Many duties were undertaken by our qualified line judges, umpires, referees and assessors at these events - too many to list all in a brief report.

Despite having a tightly-knit group of committed technical officials who continue to give their time to the sport at all levels, it is rather obvious that the demand for line judges, umpires and referees in WA far exceeds what this group is able to offer. This informs the focus of the committee on attracting and developing more technical officials.

EDUCATION AND DEVELOPMENT

In 2022 we developed and launched a new short "Introduction to umpiring and line judging" course which was delivered by Lily Buttrose and Eugene Glazman on three different occasions, coinciding with Badminton WA tournaments. This 1-hour course covers the key basic elements of the rules as well as practical considerations and tips that are essential for beginner umpires. This initiative proved to be relatively successful, with 18 people having attended the course. Several participants have shown significant interest in continuing to practice as umpires, and we hope to see and support them on their journey towards a formal umpiring qualification.

A number of WA officials have attained new qualifications and are congratulated on their achievements:

-Lily Buttrose achieved National Certificated Umpire status at the YONEX Australian National Championships in April 2022 in Bendigo VIC;

-Effi Effi achieved National Accredited Umpire status at the Australian National U17 Championships in September 2022 in Ballarat VIC;

-Eva Wu achieved National Accredited Referee status at the LiveLighter Kingsway Tournament in February 2022 in Perth (thank you Don Stockins for carrying out the assessment);

-Eugene Glazman achieved National Certificated Referee status at the Australian National U17 Championships in September 2022 in Ballarat VIC;

-Eva Wu achieved National Line Judge qualification at the LiveLighter WA Open State Championships in August 2022 in Perth (thank you Bruce Napier for carrying out the assessment).

Two WA technical officials (Sachin Vishwanath as umpire and Eugene Glazman as referee) have been accepted into Badminton Oceania's development program which aims to support officials in gaining experience at higher-level events and help them prepare for further qualifications.

Kelly Hoare and Greg Vellacott (as BWF Umpire Assessors) and Jiten Bhatt (as Oceania Umpire Assessor) attended BWF Umpire Assessment Panel Meeting and BWF/CC Umpire Assessor Workshop held in October 2022 in Odense, Denmark. This initiative was aimed at achieving better consistency in assessments / appraisals of umpires, and our WA officials can all expect to benefit from the assessors' expertise, advice and mentoring. Kelly and Greg continue to serve on Badminton Australia's and Badminton Oceania's Technical Officials Committees respectively.

STATE TEAMS

The following umpires were appointed to WA state teams competing in National Championships (carnivals) in 2022:

- Lily Buttrose travelled to Bendigo in April 2022 as WA Senior State Team Umpire, and to Adelaide in July 2022 as WA U19 State Team Umpire;
- Paul Garvey travelled to Adelaide in July 2022 as WA U15 State Team Umpire;
- Sachin Vishwanath travelled to Ballarat in September 2022 as WA U17 State Team Umpire;
- Effi Effi travelled to Ballarat in September 2022 as Geraldton U17 State Team Umpire.

GOVERNANCE

At the Committee's Annual General Meeting in March 2022, an updated version of the Committee Bylaws was adopted (and subsequently ratified by Badminton WA's Board of Management in May 2022). It was updated to reflect the currently used terminology and also clarify a few matters related to definitions of committee membership. More importantly, it established a more robust governance structure of a total of up to five Executive Members who partake in making key decisions and driving the main activities of the Committee. In addition to the existing roles of the Chair (Eugene Glazman) and the Secretary (Jiten Bhatt), the other three newly established Executive Member positions were filled (by election) by Lily Buttrose, Bruce Napier and Sachin Vishwanath. Thank you Jiten, Lily, Bruce and Sachin for your contribution during the year as we were trying to tackle some of the challenges facing the technical officials' community.

I would like to thank my predecessor Kelly Hoare who served as Chairperson of the Technical Officials Committee from March 2016 up to March 2022. Kelly made a significant contribution to supporting and developing WA's line judges, umpires and referees. Her leadership and mentoring helped many of us to be the best versions of ourselves in our technical official roles. Kelly is always keen on promoting the successes of our colleagues and helping them push towards better performance and new achievements.

In closing, I thank all our technical officials for continuing to volunteer their time and skills to support badminton at the state level as well as at higher-level tournaments. Your contribution to the sport is very valuable.

JUNIOR DEVELOPMENT REPORT

The Badminton WA Junior Development Programme in 2022 maintained the focus on inclusively engaging participation of all juniors in WA schools and communities, through providing continuous professional service to support the Foundation-to-Talents stage of development.

SCHOOL PROGRAMME

The presence of Badminton in schools is well kept with the delivery of the federal government funded Sporting Schools, the provision of school tournaments in each term, the engagement of association-endorsed coaches at school clubs, the organisation of teachers PDs, and the ATAR activities.

- Sporting Schools

Our Programme Coordinator, Kay Terry MBE, manages the booking allocation, oversees project delivery, and maintains the upkeep of equipment.

Sporting Schools is an introductory of our sport to school students from which the interest in Badminton may emerge.

- School Tournaments

Supported by staff and dedicated volunteers, Lily Buttrose continues to manage the Programme as Coordinator, Referee and Event Director.

LiveLighter School Tournaments

All four planned termly tournaments were successfully delivered to 476 students in 34 school-entries, with a Girls : Boys ratio of 51% : 49%, including hosting one event at a south-of-the-river venue which was an effort well appreciated by schools.

The “LiveLighter” message from the Association’s key sponsor, Healthway, was actively conveyed. Badminton WA programme including the Wings, coaching courses and services, as well as junior umpiring award / volunteering opportunities were widely promoted.

LiveLighter WA District High Schools Country Week - commissioned by School Sport WA for the Department Of Education

19 teams from 9 regional schools enjoyed competing and learning in the compressed 3-day Country Week, following the PM’s last-minute announcement of the National Memorial Day for the passing of the Queen. Badminton WA official and volunteers toiled through increased workload intensity to successfully deliver this event for the 14th consecutive year.

Other Tertiary Events

The Association was invited to assist at the University Games West-Series in Spring by Ryan Lin, and the finals stage of the Australian University Games in Autumn by Lily Buttrose and Eva Wu.

WINGS JUNIOR PROGRAMME

The Badminton WA Wings Junior Programme, originally established to capture the interest generated from the on-campus Sporting Schools projects, continue to present the Association's strong commitment on cultivating grassroots participation, and nurturing our juniors to engage in badminton in the long-term, either for recreational health and fitness, or striving for competitive sport excellency by providing structured training to build correct foundational skills.

The Wings Programme remains self-sufficient and independent of any government funding.

- Wings Junior Clubs

The team of Association-appointed coaches continued to dedicate in operating the Clubs. Five coaches were beneficiaries of the Coaching Mentoring Programme initiated by Dr Judith Cousins in Term 2 and 3, with feedback and recommendations provided by the Mentors.

An average of 155 players per school term regularly attended training throughout 2022, showing steady market demand in line with previous 7 years of operations, taking COVID into account, particularly with our better-established club-locations.

However, various impacts, including changes in the social, economic, and demographic environment, similar co-existing programme by other operators in the market, as well as the Association's challenge in facing the limitation on financial capability and human resources capacity, continue to affect those locations that are less stable, or set up without accurate market research. This had led to two clubs that were established in the second half of 2021 by previous management to cease, after an extended period of insufficient intake.

- Holiday Camps

Two holiday camps were organised in the January and July school holidays, successfully delivered to 40 juniors by coaches Lily Buttrose, Ryan Lin, Edward Chan, and Ryan Tan.

- Wings Tournament

An exclusive Wings Challenge delivered by Lily Buttrose and Eva Wu in October was well received by players and parents. 35 Wings juniors competed in doubles and singles matches in four divisions. Trophies and participation medallions were presented to winners and runners-up.

- Shuttle Smash

Badminton WA became engaged in Badminton Australia's new participation campaign "Shuttle Smash" with an aim to introduce badminton to children of 5 - 12 years old, by associating the Wings players in this age group with Shuttle Smash. Development Officer, Ryan Lin, was appointed as State Coordinator for this initiative. This campaign has a regional engagement relevance which could potentially enhance the current WA regional development initiatives.

COACHING REPORT

REGIONAL COACHING

Several trips to regional areas (Pinjarra, Collie, Bunbury, Albany, Geraldton, Australind, Serpentine) were made, some within the Sporting Schools Programmes, some as private coaching and others as part of the WA Schools Standards and Curriculum Authority validation pilot program related to the ATAR (Australian Tertiary Admissions Rank)

COACH MENTORING PROGRAM

A grant from the Department of Local Government, Sport and Cultural Industries was received to devise and implement a coach mentoring program. The program focuses on supporting development opportunities and higher level qualifications, mentoring newly qualified coaches and building capacity to provide sustainable programs and pathways for coaches. Commencing in June 2022 and concluding in June 2023 the program has already subsidised coaches to gain higher qualifications, plus in situ coach mentoring report material has been written and twenty three (23) mentoring visits have been carried out.

EVENTS AND TOURNAMENT REPORT

The new Tournament year commenced with this portfolio being held by the President, Mark Cunningham. In May, the Events Portfolio was moved from Mark Cunningham to Christine Ferguson.

The decision was made in 2021 during the formulation of the 2022 Tournament Programme to reduce the number of tournaments for the year by one, as we were scheduled to host the Australian Masters Games, postponed from 2021 due to Covid, combined with a lack of volunteers to cover this national event, meant the workload looked more manageable.

Kingsway Tournament (February – 180 entries)

The first tournament of the year was held with the number of entries being slightly less than previous years. It was pleasing that this tournament provided an opportunity for the certification of a new referee, Eva Wu. Thank you to Don Stockins for his assistance at this tournament as the Referee assessor.

Silver Cup (April – 230 entries)

The second tournament of the year, the Silver Cup, trialled a different format with events being played in disciplines. It was hoped this arrangement would provide flexibility making it easier for players to commit to playing during at least some of the weekend. Doubles events were played on Saturday morning into early afternoon and Mixed Doubles events were played on Saturday afternoon. Trophies being awarded immediately after the completion of the doubles finals and then at the completion of the mixed doubles finals. Singles events were played on Sunday followed by the trophy presentation.

Australian Masters Games - April

The decision to proceed with the rescheduled Australian Masters Games was made by the Board of Management in early 2022. This was both a difficult and risky decision, but it was considered the appropriate decision to make considering all the circumstances and information available at that time. This event presented a number of challenges such as the entrant information not being current (player information came from a third party) and of course the continuing spectre of Covid impacting on players. A very big thankyou to Judy Cousins who provided great assistance and direction in making this event happen. The event was handed over to Christine Ferguson shortly before the commencement date. In the week and indeed the day/night before the matches were due to commence, we were still reorganising teams and schedules due to teams or players no longer coming to Perth. I wish to acknowledge the efforts of Ryan Lin, Kim Rodgers and Judy Cousins for their assistance and the conscripts we found amongst our local WA players on the eve of the first round of matches. Our local players who agreed to play at extremely short notice either slotting into a team or making up a replacement team were heroes. The final outcome was a successful team and individual events with just a further small hiccups along the way.

EVENTS AND TOURNAMENT REPORT

Country Carnival (June long weekend -cancelled):

Unfortunately, this event was cancelled due to lack of entries. A review has been undertaken with Country Clubs and Associations being contacted for their views on the dates, format, venue etc. From the two responses received it has been decided to leave this event over the long weekend in June 2023, at Kingsway Indoor Stadium, with further work to be done on the format.

Perth Championships (June - 206 entries):

This was Eva Wu's first solo tournament as Referee. The disciplines format was again used with a swap of Mixed Doubles to Saturday morning and Doubles commencing late morning. Singles were played on Sunday. A very successful event.

WA Junior Team Championships and State Open Junior Championships (July – 12 teams, 88 players):

This combined event commenced with the Team Championships which were successful despite the low number of entries across the age groups. With the small number of teams participating, age groups were combined for the competition. Trophies were awarded to the top team within each age group. The Teams event was followed by the Individual championships with a relatively small number of players in the tournament. A big thank you to our referee, Jiten Bhatt. With the return of the various Junior National Championships taking up most of the school holiday breaks, the decision has been made to split this event in 2023, holding the individual event during the April School Holiday period and the team event in October. This is a trial and will be reviewed for 2024.

State Open Championships (August - 198 players):

This is the premier tournament of our calendar. All events except those with low numbers were played as elimination with a consolation event for those knocked out in the first round (open events excluded). Junior events are not included in this tournament with junior players still being able to compete in the graded events.

Prize Money was increased for the Open events, and prize money being allocated down to semi-finalists. A big thank you to our referee Eugene Glzman.



EVENTS AND TOURNAMENT REPORT

City of Mandurah Tournament (September -132 entries):

A successful event with the entries greatly increased from 88 players in 2021 to 132 players. We were not competing with the AFL Grand Final this year, but we did have our U/17 team away at the National Championships as well as a number of open players who did not participate. We once again wish to acknowledge the sponsorship from the City of Mandurah and the support provided by the staff at the Mandurah Aquatic and Recreation Centre. The support from the Mandurah Mixed Badminton Club and president Peter Shannon in both setting up the venue and packing up at the end, as well as umpiring was greatly appreciated, making our job so much easier. A big thank you to our referee Jiten Bhatt, who brought his wife, Riana, as a valued volunteer.

This tournament has been omitted from the 2023 calendar as we are holding the Oceania Para Championships and the Western Australia Para International in Mandurah.

Summer Championships (November – 335 entries):

There was a record entry for this final tournament of the year. A number of new players entered, including players from country areas, with specific mention of our Bunbury players. All members from Country Clubs and Associations were offered a discount on entry fees to compensate for the cancellation of Country Carnival. We also finally had enough entries to run a couple of Master's events in the 45+ Mens Doubles and Mixed Doubles. Our new Executive Officer, Ghaz Ramli, was in attendance both in his official capacity as well as a player, giving him the opportunity to view the tournament from both sides. Our major sponsor Healthways via the Livelighter campaign provided fruit and water bottles for players. Thank you to our Admin Officer, Sam Jones, for managing the distribution. Eugene Glazman was the referee overseeing this very large tournament.

A fantastic end to the 2022 Tournament Year.

Para Tournament (December – cancelled): This event was cancelled due to scheduling problems.

The Badminton WA tournaments would not be able to proceed without the assistance of a very small number of volunteers, plus support from office staff and the Tournament Officials Committee (TOC). A big thank you to the TOC Chairman, Eugene Glazman, in his first year in this position. At the State Junior Championships, an "Introduction to Umpiring Course" was initiated by Eugene which continued to be run at the metro tournaments for the rest of 2022.

Thank you to our Grading Committee which is now down to one person, the Chairman, Jeff Tomlinson (an opportunity for a new volunteer?). Thank you to our three currently active referees already mentioned, Eugene Glazman, Eva Wu, Jiten Bhatt for their contribution. Our small number of regular volunteers including our announcer, Trevor Briedis, Judy Cousins, Lisa Chapman, Kim Rodgers, Kay Terry, Lily Buttrose (an umpire and volunteer), John Granville and Rita Bonjour (both recipients of a Service Award in 2022) - we could not run tournaments without you.

We look forward to building on our successful 2022 events.





Note 1 : Summary of Significant Accounting Policies

Basis of Preparation

This financial report is a special purpose financial report prepared in order to satisfy the reporting requirements of the Associations Incorporation Act 2015 of Western Australia. In the opinion of the Board, the association is not a reporting entity because it is not reasonable to expect the existence of users who would rely on the association's general purpose financial statements for information useful to them for making and evaluating decisions about the allocation of resources.

The financial report has been prepared in accordance with the Associations Incorporation Act 2015 of Western Australia, the basis of accounting specified by all Accounting Standards and Interpretations, and the disclosure requirements of Accounting Standards AASB 101 Presentation of Financial Statements, AASB 107; Cash Flow Statements, AASB 108 Accounting Policies, Changes in Accounting Estimates and Errors, AASB 1031 ; Materiality and AASB 1054: Australian Additional Disclosures.

The association has not assessed whether these special purpose financial statements comply with all the recognition and measurement requirements of Australian Accounting Standards.

The financial report has been prepared on an accrual basis and is based on historical costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in preparation of this financial report.

(a) Income Tax

The association is exempt from payment of Income Tax under Subdivision 50-A of the Income Tax Assessment Act 1997.

(b) Property, Plant & Equipment (PPE) & Software Development

Office equipment is carried at cost, less where applicable any accumulated depreciation.

The depreciable amount of all PPE is depreciated over the useful lives of the assets to the association, commencing from the time the asset is held ready for use.

Software development is similarly carried at cost, and the cost is amortised over the assessed useful life to the association.

The depreciation rates for office and other equipment varies accordingly, prime cost and reducing balance methods.

The amortisation rate for software development has been assessed at 5 years prime cost, i.e. 20%pa.

For the year ended 31 December 2022

Note 1 : Summary of Significant Accounting Policies (cont'd)

(c) Impairment of Assets

At the end of each reporting period, the entity reviews the carrying values of its tangible & intangible assets to determine if there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, is compared to the asset's carrying value. Any excess of the asset's carrying value over its recoverable amount is expensed to the income statement.

(d) Employee Benefits

Provision is made for the association's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits have been measured at the amounts expected to be paid when the liability is settled.

(e) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of six months or less.

(f) Revenue

Revenue comprises mainly of grant income (federal, state & local government level), member affiliation & registration fees, event program & representative team fees, donations, bank interest and other income or recoveries.

Revenue is measured at the fair value of the consideration received. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

If conditions attached to grant revenue must be satisfied before the association is eligible to receive the grant, then those conditions must be satisfied, before recognition.

Revenue from the rendering of a service to a customer is recognised upon delivery of the service to the customer.

Donations are recognised as revenue, as and when received.

Interest income is recognised on an accrual basis.

(g) Goods and Services Tax

Revenues, expenses and assets are recognised net of the amount of GST.

Trade receivables and payables are stated inclusive of the amount of GST recoverable or payable. Accruals of expenses and deferrals of revenue are booked exclusive of GST.

The net amount of GST payable to or recoverable from the ATO is included in the Balance Sheet under liabilities payable or assets receivable.

(h) Trade and other payables

Trade and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the association remaining unpaid. The balance unpaid is recognised as current liability with the amounts normally paid within 30 days of recognition of the liability.

For the year ended 31 December 2022

Note 1 : Summary of Significant Accounting Policies (cont'd)

(i) Leases

Lease payments for operating leases, where substantially all the risks and benefits remain with the lessor, are recognised as expenses on a straight-line basis over the lease term. For Leases that have significantly below market terms and conditions, principally to enable the association to further its objectives (commonly known as peppercorn/concessionary leases), the association has adopted temporary relief under AASB2018-8 and measures the the right of use assets at cost on initial recognition.

(j) Key Estimates & Judgments

The association exercises judgment in calculating employee leave entitlements as indicated at Note 1(d).

The association has exercised judgment in assessing eligibility for past Covid19 pandemic measures, and there is no known uncertainty as to past JobKeeper or CashBoost claims made.

(k) Economic Dependence

The association's scale of operations is dependent upon some recurring government grants. At the date of this report, the Board has no reason to believe that those recurring will not continue into the future. In the unlikely event that they may not, then the Board is of the opinion that the association's operations would continue, either member funded or scaled back to greater voluntary effort.

(l) Reserves

The Court Official Reserve account was established to allocate a portion of revenue from tournaments to assist in the development of Court Officials.

The State Junior Teams Fundraising Reserve account was established to allocate specific fundraising effort from parent fundraising activities.

Note 5a Contingent Liabilities

During the 2021 financial year, the Board of Management engaged a law firm to provide legal advice in relation to a potential historical abuse claim. In that year, the association incurred legal expenses of \$9,927 (GST excl) in the taking of this advice. This matter has not progressed from the initial claim. There is no further outcome in relation to this matter as at the date of signing of these financial statements, & no additional liabilities are known. Any suggestion of liability owed by the association has been denied. There are no further matters of contingent liability arising in 2022 or subsequent to balance date.

Note 5b Events Subsequent to Balance Date

The association leases office and storage premises at 130 Kingsway, Madeley, from the City of Wanneroo, for a minimal annual rental. The 2017 Crown lease applicable completed its 5 year term in November 2022, and monthly terms continue. The association has been offered a further 5 year (+ 2 year option) renewal of a Crown Lease in similar terms & lease conditions, in late 2022. At the date of signing of these financial statements, negotiations continue with the City on the exact wording of the terms and conditions of the new Crown lease. The Board of Management expects to be able to satisfactorily re-negotiate the new lease shortly, and have it executed by all parties.



Qualified Auditor's Opinion

We have audited the accompanying financial report, being a special purpose financial report, of The Badminton Association of Western Australia (Inc.) ("The Organisation"), which comprises Balance Sheet as at 31 December 2022, Income and expenditure statement, statement of cash flows, statement of changes in equity, a summary of significant accounting policies, other explanatory notes and the statement by the members of the board.

In our opinion, except for the effects of the matters described in the Basis for qualified opinion section of our report, the accompanying financial report of The Association is in accordance with the constitution and Associations Incorporation Act 2015, including:

- a) giving a true and fair view of The Association's financial position as at 31 December 2022 and of its performance and its cash flows for the year ended on that date in accordance with the accounting policies described in Note 1; and
- b) complying with Australian Accounting Standards to the extent described in Note 1.

Basis for Qualified Opinion

Opening balances

I was appointed as auditors of The Organisation for the year ended 31 December 2022 and were therefor unable to satisfy ourselves by alternative means concerning the opening balances as at 1 January 2022 and closing balances for the year ended 31 December 2021.

Cash receipts and payments

Cash sales and payments make up a reasonable portion of the revenue and expenses for The Organisation. The Organisation has determined that it is impractical to establish control over the collection of revenue and payment of expenses prior to entry in its financial records. Accordingly, as the evidence available to us about revenue and payments to and from these sources was limited, our audit procedures for cash revenue and payments had to be restricted to the amounts recorded in the financial records. Therefore, we are unable to express an opinion on whether revenue and payments obtained by or provided by cash are accurate and complete.

Inventories

We were unable to verify the existence of inventory as at 31 December 2022 as we were not appointed before this date. Further due to the lack of records kept (as per the qualification made in the above paragraph), we are unable to verify any inventory balances and therefore do not provide an opinion on this balance and any adjustments that may have a flow on effect on the remaining financial statements.

I conducted our audit in accordance with Australian Auditing Standards. My responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Report* section of our report. I am independent of the Entity in accordance with the ethical requirements of the Accounting Professional and Ethical Standards Board's APES 110 *Code of Ethics for Professional Accountants* (the Code) that are relevant to our audit of the financial report in Australia. I have also fulfilled our other ethical responsibilities in accordance with the Code.

I believe that the audit evidence I have obtained is sufficient and appropriate to provide a basis for our opinion.

Emphasis of matter - Basis for Accounting

We draw attention to Note 1 to the financial report, which describes the basis of accounting.

The financial report has been prepared for the purpose of fulfilling the Committee financial reporting responsibilities under the constitution and Associations Incorporation Act 2015 (WA). As a result, the financial report may not be suitable for another purpose. Our opinion is not modified in respect of this matter.

Committees' Responsibility for the Financial Report

The Committee of the organisation is responsible for the preparation and fair presentation of the financial report in accordance with the financial reporting requirements of the Constitution and Associations Incorporation Act (WA), and are appropriate to meet the needs of the members.

The Committees' responsibility also includes establishing and maintaining internal controls relevant to the preparation and fair presentation of the financial report that is free from material misstatement, whether due to fraud or error; selecting and applying appropriate accounting policies; and making accounting estimates that are reasonable in the circumstances.

In preparing the financial report, Committee is responsible for assessing the Association's ability

to continue as a going concern, disclosing, as applicable, matters relating to going concern and using the going concern basis of accounting unless management either intends to liquidate the Association or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Association's financial reporting process.

Auditor's Responsibility

Our objectives are to obtain reasonable assurance about whether the financial report as a whole is free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion.

Reasonable assurance is a high level of assurance but is not a guarantee that an audit conducted in accordance with the Australian Auditing Standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of this financial report.

I communicated with the management committee regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that I identify during my audit.
