

President's Report

It is my pleasure to present the 2021 annual report for Badminton WA.

As every year, 2021 was a busy year. Pandemic challenges continued to affect all our lives and called for patience and creative solutions to many new and unexpected problems. Regardless of all these challenges Badminton WA pushed forward and still managed to deliver 13 major events during the year including all 7 major tournaments listed on our calendar.

I would like to take this opportunity to thank everyone involved in delivering these events. Every year we seem to only have a small team of very dedicated people who make these events happen and without these people they would not be possible.

For the first time Para Badminton was introduced to the Paralympics. Although Tokyo 2020 was a year late Badminton WA was delighted to have the only 2 players representing Australia on the biggest stage in world badminton Caitlin Dransfield and Grant Manzoney were the first ever Para-Badminton players to represent Australia at a Paralympics and they did so with pride and distinction. Congratulations to both Caitlin and Grant on their achievement. I would also like to acknowledge the support of all the Badminton WA members who helped these 2 players reach their lifelong goal.

21 saw the cancellation of all national events. This was extremely disappointing because WA has a strong group of talented juniors who are being coached and developed by a group of very dedicated

and passionate coaches. Hopefully 2022 will see the return of national events and Badminton WA will again return to challenge for medals at these events.

Locally 2021 has seen positive communications with more regional badminton centres than in past years. Ryan Lin and Lily Buttrose have done a terrific job bringing Albany back and establishing an association consisting of 5 Albany clubs. Badminton WA has also been influential in helping re-establish the South Suburban Badminton Association and I would like to acknowledge Kelly Hoare as president of this association and thank her for taking on this role.

On a national level Badminton WA have been very active working with BA to finalise the rebranding of Badminton across all states. In addition, we have offered our assistance and direction towards the new format for national events. we have offered our opinion on selection criteria and nomination procedures for para and able-bodied teams, we have also offered assistance and expertise regarding the change of insurance provider for BA. Over the past 5 years Badminton WA have been very determined for BA to introduce an U13 national event and we are cautiously optimistic that the first national U13 event will happen in 2022.

I would like to take the opportunity to thank current board members Kim Rodgers and Judy Cowper for their contributions during these discussions. Other projects that continue are the equalisation of costs for all national teams and Badminton WA joining Sports In-



tegrity Australia. At the 2021 AGM Anthony Mackaiser was elected as president. Unfortunately, Anthony decided work commitments were too difficult and resigned soon after. I would like to thank Anthony for his contribution to Badminton WA during his time on the board as a board member and as the stand in president once Eva Wu had stepped down from the role.

Personally, I only took on the role of president of Badminton WA in May 2021. I have found the role challenging but extremely rewarding. I would like to thank my current board members for their support and contributions over the last year and would also like to thank the office staff, Rick Wolters, Ashleigh Payne and Ryan Lin for their hard work and dedication throughout a difficult year. Badminton WA continues to strive to build our sport and offer our members better opportunities to enjoy the sport of badminton at all levels.

We look forward to improving our sport in all aspects in 2022 and hope to see you on the courts.

Executive Officer's Report

Badminton WA reflected the broader Western Australian economy and sporting organisation through a display of resilience, compromise and common sense. Once again we were much more fortunate than our colleagues in the rest of the country as we continued to deliver our programs, tournaments and offer new opportunities to members and those aspiring to join Badminton WA.

Financially, Badminton WA again saw challenges with reduced income streams. However unlike in 2020 our resilience and good fortunate as a State saw us able to deliver many of our programs and tournament relatively unaffected. Unfortunately our High Performance program was heavily affected with the opportunities to represent at the state and national level greatly affected. We are grateful for the support of our valued sponsors and program partners to enable to continue operations at such a level. Of the 18 tournaments scheduled to be held in 2021, in the end we were pleased to be able to host 10 tournaments, far more than other badminton State or Territory.

Our para program continues to build its depth and strength. The year's highlight was to see two of our members represent Australia at the Tokyo Paralympics. Moreover this was the first occasion that Australia had para badminton representatives at the Paralympics. Congratulations are extended to Caitin Dransfield and Grant Manzoney to continue being role models and pioneers in Western Australian para badminton, and beyond. Para badminton categories continue to be included in each tournament whilst para badminton coaching courses and "come and try" days have been hosted to encourage more support.

Athlete coaching and coach development is one of the strong pillars of our operations. With effective and efficient leadership from our coaching coordinators members receive excellent support and skill development to a range of services including junior development, sporting schools and our representative teams. Our very popular and important junior pathway program Shuttle Time Wings, was once again very successful. We have increased our venue range to 11 venues. The introduction of two age categories at most venues was a great success with coaches, players and parents alike, leading to improved coaching, improved outcomes and experience for children and a greater value for the parents.

Our elite athletes continue to be developed and recognised. COngratulations to Yingxiang Lin and Milain Ranasinghe selected in the Australian Badminton Falcons team, whilst Julian Lee, Tim Sentosa, Bernice Teoh and Joanne Zheng were selected into the Junior Falcons team. Badminton WA continues to identify, grow and develop our young talent and assist them on their pathway to Australian and international representation.


Our Member Services and Event Support Office Ashleigh Playle continues to bring improved members service and support systems as well as financial controls and information technology to the role. Administratively Badminton WA welcomed our new Community Services Engagement Officer Ryan Lin. Ryan has been working to engage new Clubs, work to engage new athletes with a disability to join badminton and assists in developing our coaches.

As Executive Officer I am grateful for a strong and committed group of volunteers that are central in making Badminton WA such a respected sporting organisation. These volunteers range from our Club President and Committee through coaches, program coordinators, tournament officials to "everyday helpers". Badminton WA enjoys great support from the corporate and government sectors and continues to be in a stable financial position. We work closely with our key stakeholders and have excellent corporate relationships with them.

Membership

Weathering the COVID Storm

Membership levels were affected in 2020 by COVID and the difficulties for players to participate with their Clubs. It has been pleasing to see the resilience of badminton in WA with the return to court and the recovery in sport. Whilst there is always room for improvement our 2021 membership levels are encouraging given the circumstances.

There had been encouraging increases in junior membership of Shuttle Time Wings memberships, tournament players and school tournament memberships.

Membership in 2021 saw a 22% reduction in total membership from 3098 to 2415 members. Category membership saw a reduction for Adults, down 10%,


Juniors were down 8% whilst Seniors were also reduced by 30%. The cancellation of 5 or more events further reduced event membership levels by 45%. Renewed efforts will be undertaken in 2022 to build on the recovery momentum.

MEMBERSHIP CLUB AND ASSOCIATIONS

Whilst playing membership were heavily affected most of the Clubs, although taking a break during the lock down periods, continued on once restrictions were lifted.

Each year there is a turnover of Clubs. This is as a result of a range of factors including turnover of office bearers available to manage a club, insufficient retention of members to form a club, closure of venues forcing clubs to relocate as well as the aging demographic of some clubs.

2021 saw 6 clubs discontinue membership, with 6 new Clubs added to the Club list.





Inclusion and Para-Badminton

What a year 2021 was for Para Badminton here in Western Australia.

Para Badminton made its Paralympic debut in Tokyo in August, 2021. Badminton Australia sent 2 athletes to represent Australia, both being West Australian.

Our own Caitlin Dransfield and Grant Manzoney realised their dream of representing their country at the Paralympic Games. Caitlin competed in the Women's SL4 class and Grant in the Men's WH2. Both Caitlin and Grant worked tirelessly with their coach, Mark Cunningham, to achieve their dream. Both Caitlin and Grant represented their country and Badminton WA with pride. We, at Badminton WA, congratulate Caitlin and Grant on their achievements and we are immensely proud of them both.



Unfortunately, due to COVID restrictions, the National Para Badminton Championships did not go ahead in 2021. Our athletes, Grant Manzoney (WH2) and Lochan Cowper (WH1) retain their No. 1 Australian rank-

ings. We are hopeful that they will be given the opportunity to defend their titles in 2022. We are also hopeful that the 2022 Para Badminton Oceania Championships will proceed, as scheduled, in July 2022 giving Grant and Lochan the opportunity to defend their Oceania WH1 and WH2 Singles Titles and, jointly, their Doubles Title.

Locally, BadWheels has had a makeover. We felt that the name "BadWheels" did not reflect who we are and what we do so the decision was made to rebrand "BadWheels" as Para Badminton Western Australia.

Badminton WA continues to support and promote inclusion in our sport by offering an inclusive program on Thursdays at Kingsway. These sessions are well attended and run under the guidance of coach, Mark Cunningham. All Badminton WA state tournaments, as well as the South West Championships held in Mandurah, offer opportunities for people with disabilities to enter. We also held a dedicated para tournament in December. A new south of the river inclusive group started up in February. This is a 10 week trial supported by the City of Mandurah and run by Mandurah Mixed Badminton Club. If successful, we hope to see this group continuing beyond the trial period.

Badminton WA ran a para development squad for a time earlier in the year. With Covid

restrictions easing and national and international tournaments restarting in 2022, we will be looking to get the Para Development Squad up and running again.



Paralympic Australia ran 2 Come and Try Multisport Events. Badminton WA attended both events, showcasing our sport to future Paralympians.

Badminton WA is extremely proud of its Inclusive programs. 3 Western Australian athletes hold top 20 positions in the World Ranking, we have 2 National and Oceania Champions and 2 Paralympians. We will continue to work to improve our programs, grow our player base and offer more opportunities for people with disabilities to enter our sport.





In 2021 members of the Court Officials Committee provided their time and expertise in assisting in the conduct of tournaments and events at which they officiated. During this time Western Australia was fortunate enough to be able to conduct tournaments to enable members of the Court Officials to practise and enhance their skills, whether it be in refereeing, umpiring or line judging in support of the successful staging of those events, tournaments and other competitions.

Kelly Hoare ran an umpire's course in February 2021 whereby there were 12 candidates, most of the candidates wanted information to take back to their clubs and or update their own knowledge, however there were a couple who have gone onto umpire at our local tournaments in 2021. Kelly and Jiten also met with Badminton Australia CEO Jamie Parsons in May 2021 where he updated us on Badminton Australia's new logo and how COVID19 was affecting the National Carnivals.

Thanks, must go to Jiten Bhatt, Greg Vellacott, Lilly Buttrose, Bradley Chen, Nicholas Nguyen, Eugene Glazman, Paul Garvey, Eva Wu, Sachin Vishwanath, Grant Manzoney, Matthew Cunningham and Sreejith Kandy as they give of their time to either assessing, referee and or umpire at all tournaments held at Kingsway and Mandurah.

NATIONAL CARINVALS

All national carnivals were cancelled in 2021 due to COVID19. The Badminton WA policy of meeting the travel and accommodation costs of State Teams umpires continues to be a positive move which should continue to encourage any interested persons to consider achieving a form of umpire qualification and then to utilise such qualifications in support of the players and coach and manager representing their State. Local Tournament budget also continued in 2021 which allowed WA qualified umpires to gain great experience with some well-earned pocket money.

INTERNATIONAL EVENTS

Greg Vellacott in his capacity as BWF Umpire Assessor did not travel. Kelly was chosen to attend the 2020 Olympics in Tokyo Japan, however decided not to travel and retired from umpiring. Kelly will continue her new role as BWF assessor albeit online at the moment. Jiten Bhatt in his capacity as BWF Certificated and semi professional umpire did not travel, however refereed and umpired at our local tournaments held at Kingsway.

Members of this Committee can be very proud of their contribution to our sport at all levels. Their contribution at a national and international level is especially significant and their essentially voluntary commitment to our sport is a tribute to the energy and enthusiasm they bring to the support of the sport at all levels.

COMMITTEE MATTERS.

Kelly Hoare has decided not to continue in the position of Chairperson for the next term. At the AGM in 2022, The BAWACOC will be looking for a Chairperson for term of 2 years from March 2022 that expires at The Badminton WA AGM in 2024. Jiten continues in the position of Secretary for a term of 2 years from March 2021 that expires at The Badminton WA AGM in 2023.

Badminton Australia Court Officials Committee – Kelly Hoare continues as a member of this committee. Badminton Oceania Technical Officials Committee – Greg Vellacott continues as a member of that committee. The members of this Committee are proud once again in 2021 to be able to report to The Badminton WA not only on their officiating services to The Badminton WA, but to Badminton Australia, Badminton Oceania and Badminton World Federation as part of their service to the sport.

Junior Development

The Badminton WA Junior Development Programme consists of several different aspects that are operated through different formats and approaches, often incorporated or alongside other participation and development initiatives.

Foundation Programme

School Badminton Programme

Sporting Schools

Kay Terry remains as Programme Coordinator, supported by the Executive Officer. 13 BAWA coaches delivered the programme to over 1,680 students at 27 schools.

School Tournaments:

Lily Buttrose continues to manage the Programme as Referee and Tournament Director, supported by staff and committed volunteers. Four termly tournaments were successfully held and attended by 608 high school students from a total of 47 school-entries. One primary school tournament was planned, however, was not met by enough interest from schools to eventuate. WA District High School Country Week Badminton WA successfully delivered this five-day event on 20th - 24th September 2021 for School Sport WA for the thirteenth consecutive year, Lily Buttrose continued as Competition Manager, supported by committed volunteers. Caitlin Dransfield, as our athlete representative, attended the Closing Ceremony and present Sportsmanship Award.

Community Badminton Programme

Wings Programme

Badminton WA Wings Junior Programme maintains strong in the 7th year since establishment, with Wings Junior Clubs operating throughout the year by dedicated coaches and attended by over 800 players in Perth metropolitan suburbs of Yanchep, Craigie, Duncraig, Wanneroo, Scarborough, Wembley, Rossmoyne, Canning Vale, Armadale, Cockburn, and Mandurah.

The Programme is independent of any government funding, and is well-regarded by Badminton Australia to use a model to develop the new national participation programme to be launched in 2022.

Member Associations and Clubs

BWF Shuttle Time Teachers courses were delivered in Bunbury (March), Geraldton (July), and Albany (September) to help regional association and club members, as well as school teachers with sufficient information and resources to teach badminton at clubs and schools. Kay Terry and Lily Buttrose conducted the courses with assistance from Dr Judith Cousins and Ryan Lin.

A number of affiliated clubs, such as Nick Kidd Badminton Academy, An Yu, and SKM, offer extensive juniors training and competition activities.

Independent Groups

Some juniors work with independent coaches and groups. The actual statistics remain unclear. Badminton WA's newly appointed Community Engagement Officer is dedicated to work on identifying ways of encouraging integration and participation.

Junior Competition in Australasia / National and Badminton WA Sanctioned Tournament All Australasia and national junior championships were postponed due to COVID. The State Junior Championships was successfully held in July school holidays.

Nearly every BAWA sanctioned tournament has juniors divisions. Junior players from local Foundation programmes such as the Wings, Talent programme such as the High Performance Squad and State Teams, as well as players from regional centres and inter-state participated in our tournaments.

High Performance Programme

Junior High Performance Squads continue to operate in both north and south of the river.

Forward View

Our juniors mark the future of our sport. It remains our upmost commitment to:

enable more juniors taking playing badminton as a fun and rewarding sporting experience to their physical and mental wellbeing; nurture the development of juniors by creating accessible and inclusive programmes to provide professional progressive training and opportunities to play; ensure juniors needs are supported in their development pathway by providing appropriate training and competition opportunities. Encourage and develop more qualified coaches to engage in delivering junior programmes.

Juniors Development and Schools Programme

2021: ANNUAL REPORT: SPORTING SCHOOLS

The Sporting Schools programme is federally funded by SportAus, with schools applying for grants to support their sporting activities. The aim of the programme is:

'Helping schools increase children's participation and opportunities in sport'.

In 2021 thirty three (33) schools received grants for badminton programmes. Sometimes only one class was involved, sometimes the whole school and children from pre-primary to Year 8 were introduced to the sport. Programmes ranged from four sessions for a single class to sixteen sessions across several classes.

There were five (5) regional schools participating this year. These programmes were mostly of two days duration with all children in the school being involved.

Eight (8) coaches, all nationally qualified and registered, supported programmes and approximately 1500 children participated.

In 2021 the Coaching Development programme included:

The provision of coaches for High Performance squads, Sporting Schools sessions, Wings Clubs, groups & individuals, plus managing coaching courses in metro and regional areas, facilitating a coaching workshop, and liaising with Badminton Australia on all coaching matters.

BA FOUNDATION COURSE



This course, held in May, is the first step on the National Coaching Pathway and leads coaches into the Badminton World Federation (BWF) courses.

The course has two components:

- * Online work.
- * One day (8 hours) practical session. The course was held at the Kingsway Stadium and Badminton Australia provided the Tutor, Mr Peter Roberts, a highly cre-

dentialed former badminton champion and long time coach. Two WA Coaches (Lily Buttrose & Ryan Lin) attended the course and on completion of further online work attained Tutor level. The course was subsidised by Badminton Australia, so cost to candidates was reduced to \$60 for the practical component. Nine (9) candidates completed the course, with all being successful.

BWF SHUTTLETIME TEACHER COURSES

Three regional ShuttleTime Courses were held: Bunbury (March), Geraldton (July) and Albany (Oct). Tutors; Kay Terry & Lily Buttrose. Twenty seven (27) candidates successfully completed the courses.

OCEANIA BADMINTON CONFEDERATION

Planned BWF Level 1 Tutor and BWF Level 2 Coach courses were postponed due to Covid restrictions.

BADMINTON AUSTRALIA

A new annual registration process was initiated, replacing the previous four-yearly registration.

The national coach insurance scheme was modified to include insurance for private coaching (at additional cost). The BA Executive Officer visited WA and the opportunity for a meeting covering coaching matters was very useful. The Sport Integrity Australia Learning System was co-branded with Play By the Rules, with some

of the courses now becoming pre-requisites for BA coaching courses. A Coach Development Officer was appointed to handle all registrations, and courses. Additional coaching resources were developed in partnership with BADMINTON FAMILY, an online hub specifically designed fobadminton coaches.



COACHING WORKSHOP

Held in December, twenty two coaches attended, with Part 1 of the workshop specifically focused on coaches of Wings Junior Clubs. Part 2 covered a range of topics, including Sporting Schools work, BA registration and coaching pathway information, Performance Partner Pathways report and the 2022 Coach Development schedule.

REGIONAL COACHING

Several trips to Country areas (Dandaragan, Cunderdin, Geraldton, Albany, Leinster) were made, some within the Sporting Schools Programmes and others as private coaching.

REGIONAL DEVELOPMENT

Western Australia badminton is well supported in our regional areas. 2021 saw 13 clubs deliver badminton opportunities to players in country regions. These Clubs managed to host regular social and pennant competitions for a range of groups from tiny beginners, to school competitions, to men and women adults as well as to senior groups.

2021 saw Badminton WA support these efforts with trips to towns such as Geraldton, Bunbury, Mandurah and Cunderdin to deliver coaching and school opportunities, to grow the game and support the local volunteers in those areas.

The City of Mandurah LiveLighter SouthWest Championships is a well established event on the calendar and was successfully hosted at the Mandurah Aquatic and Recreation Centre once again, albeit reduced numbers as a result of the hosting of the AFL Grand Final in Perth. A successful hosting of the 2021 Country Carnival saw 12 teams return to Mandurah from Bunbury, Geraldton, Kalgoorlie, Mandurah, and Perth to battle for the titles.

Our Sporting School program took coaches into the country to centres such as Djiji Djiji Aboriginal School Bunbury, Balingup Primary, Mount Barker Community College and Newton Moore SHS Bunbury. We also supported once again the hosting of the Livelighter WA District High School Country Week.

It was pleasing to see the regular hosting of "Come and Try" days by Clubs especially at Bunbury and Geraldton as clubs seek to introduce new players to the game and their Clubs. Both these clubs are active in developing

Shuttle Time coaching courses were conducted in Albany, Bunbury and Geraldton. Plans are being developed to conduct Shuttle Time coaching courses in Kalgoorlie and Christmas Island in 2022. Thank you to everyone who organized or contributed to activities for regional areas in 2020.





The Kingsway Indoor Stadium continues to be our premier venue for badminton in Western Australia. The venue, located in Madeley and managed by the City of Wanneroo, houses our administrative centre, the venue in which we host the majority of our events as well as the location of our support equipment required for tournaments.

Kingsway Indoor Stadium is perfect for hosting small to large tournaments and events. With great support from the City of Wanneroo badminton is able to have a professional home to operate from. We were fortunate to have the services of a commercial cafe to support our volunteers during tournaments. Unfortunately the cafe did not continue its lease with the City. With the growth in competition numbers and the geographical diversity of our competition membership 2021saw a focus on building relationships with new stakeholders in order to meet the demand for facilities and to develop an essence of bringing the sport to the people and not the other way round. Moe tournaments have been hosted in the southern part of the city to meet the needs of clubs and schools in that area.

Discussions have commenced with a range of venues to gain access to the facilities and in some cases discussions regarding the upgrade of existing facilities. These discussions include City of Armadale, City South Perth, City of Wanneroo, City of Joondalup as well as the City of Swan.

2022 will see a conscious effort to host more tournaments, promotions, coaching and other courses in the south of the river locations at locations such as Perth Badminton Arena and Armadale Badminton Centre.

Planning and bookings have been made to broaden the venues we use across our programs including Shuttle Time Wings, Coaches course, Para Development squad training, High Performance training as well as to our regular tournament venues.





Events and Tournaments

2021 began with a schedule of 20 tournaments including local, region, club delivered as well as school focused events.

With the challenges of COVID-19 we were pleased that we eventually were able to deliver 13 events including Kingsway Tournament, Junior State Championships, Perth Championships, 4 of the five planned school tournaments, SKM events, Country Schools week, Open State Championships, Country Carnival, South West Championships, Para Challenge and the Summer Championships.

Due to Western Australia's successful management of the pandemic we were able to deliver many more events than our counterparts in other states and territories of the country.

- * social media channels.


The "Badminton Shots" e-newsletter remains crucial to our aim to communicate important news, event promotions and information regarding governance matters, coaching and umpiring courses, tournaments, training camps, and other events as well as general news.

We have made fantastic progress with our Facebook page during 2021. The Facebook page, which now has more than 2,500 followers, has been important to helping us keep our members and fans up to date in these challenging times and it continues to go from strength to strength.

The website is an important channel for information regarding events and programs as well as the 'go-to' destination for people wanting info on clubs and associations, memberships, coaching and development programs and much more. Members can idetiy courses, evenmts, torunaments and programs, sign up and pay for these online with easy access.

These platforms are often linked as members consume their information in a range of mediums so ensureing the message gets to its recipient is vital for the success of badminton in WA.

Supporting these electonic platforms are a range of strategies designed to inform and streamline processes including publication of flyers, posters, "how to plans" and promotional items.



A major focus of Badmiton WA was improving the communication and connection both between Badminotn Western Australia and Badminton Australia but also improving the communication pathways between Badminton WA members and Badminton Australia.

Closer relationships with Badminton Australia has resulted in improved information and awareness at the local members level. The Badminton Australia messaging around programs such as the new Falcons Development program, the High Performance Pathway, the Shuttler newsletter and the new National Championships model has seen greater engagement and appreciation for the role of each of the governing bodies.

Coaches are better connected to their colleagues through a new coach registration and education program, feedback is regularly sought through online surveys and forums. The goal is to have more people playing, more often, with greater skill and with more enjoyment.





Financials

Treasurer's Report to the Re-convened Badminton WA AGM 2022

The Board of Badminton WA is pleased to present for your AGM 2022 adoption, the Audited Financial Statements for the calendar year (our adopted financial year), that ended 31 December 2021.

To assist with the ease of reading thereof, here is a brief glossary of acronyms that have been used in the Financial Statements due to software lineage limitations (and also used by me in this report):

- (N/R) Non-Recurring or Non-Recurrent (ie possibly one-off, in respect of grants income)
- DLGSC Department of Local Government, Sport & Cultural Industries (WA state govt dept, formerly DSR-WA, WA Dept of Sport & Recreation)
- IIP Industry Investment Program (re-current grant program of the DLGSC for SSO's)
- BO Badminton Oceania (Inc), our Olympics Sport's regional confederation & BWF affiliate
- SCPG Social & Community Participation Grant (Cwth Govt program administered by the Dept of Social Services [DSS], specifically titled 'NDIS Information Linkages & Capacity Building' grant program for 2020-21)
- JK/CFB JobKeeper/CashFlowBoost (being Covid19 economic measures through ATO by Cwth Govt statutes)
- BA Badminton Australia Ltd (our National Sporting Organisation, NSO)(& BO affiliate)
- WC Workers Compensation (WA Statute covered worker insurance scheme)
- CBA, ING, P&N Cwth Regulated Australian Banks operating under those monikas
- MD Maturity Date (pertaining to bank term deposits)
- SG, PAYGW- Superannuation Guarantee & Pay As You Go Withholding (payroll sourced financial obligations under Cwth statutes)
- KISS Kingsway International Sports Stadium (operated by City of Wanneroo, CofW)

The reality is that BAWA was much closer to approx break even or small surplus over the last 2 financial years (2020 2021) when those 2 years are combined. Reported 2020 audited result was \$33k approx surplus, and this now reported audited 2021 result \$21k approx deficit = a net \$12k surplus. The averaged results are able to be compared to budget presentations to SGMs of \$23k deficits for both 2020 & 2022.



The audited financial statements for 2020 presented to and adopted by the AGM 2021, which were prepared without BAWA Treasurer input (due to bereavement circumstances), were clearly and are now seen to be substantially in error, and included an overstatement of prepayments at 31/12/2021 by at least \$19k, and an overstatement of deferred revenue, being \$6k (of 2019 balance date revenue deferred) not properly reversed out of the balance sheet in the 2020 financial statements presentation, and other less significant mis-statements and errors in the 2020 Balance Sheet presentation that was adopted.

Where possible, adjustments (errors, oversights) that were clearly able to be attributed to the 2020 year (\$3.7k net positive items), they have been reported as net Prior Period Adjustments in the Statement of Changes in Equity. Where irreconcilable (errors, oversights) cannot be easily attributable to either 2020 or 2021 calendar years, they have been left in the reported year 2021 financial results, by agreement with the Auditor.

Some hopefully helpful commentary on the reported \$20.9k deficit for 2021 and balance sheets now being presented for AGM 2022adoption include:

- In 2020, we received substantial (N/R) JK/CFB assistance via the ATO, to help keep us going through the Covid19 pandemic, some \$47k all up, not continued into 2021
- Memberships Expense reduced in 2020 from BA discounting 75% on their membership fees to the 'States' (=SSO's such as us), increased from \$4.3k to \$14.5k. The latter \$14.5k is still partially discounted, and not yet back to full CPI indexed fees as provided in BA's Rules, until their 2022/3 financial year.
- The savings in Membership Expense and windfall of JK/CFB enabled BAWA to discount its own membership fees by some \$40k (50% discount was passed on to our members, in recognition of Covid19 pandemic impacts to our sport). This reflects in our own membership revenue increasing from \$39.4k in 2020, reverting to \$81.8k as BAWA in turn ceased its 50% discounting.
- There was also saving under the Insurances Expense in 2020, reverting from discounted premiums in 2020 to non-discounted premiums in 2021, coming mainly in support from the BA group insurance underwriter SportsCover Australia, in recognition of reduced risk for the group plan Insurers during Covid19 pandemic measures. Our overall Insurance Expense shows as increasing from \$15.9k in 2020 to \$24.3k. This was also in part due to increased Workers Compensation premiums from an increased payroll expense, and was also due to increased cover for Office/Contents cover, as we re-assessed with the brokerage for loan equipment, items such as wheelchairs, additional office equipment, etc.

- Payroll expenses increased to (N/R) grant funding secured in 2021, flowing in part also to 2022, as shown (itemised) in the Income & Expenditure Statement for 2021. This additional grant funding helped us to employ on a part-time basis a Community Engagement Officer (aka, a Development Officer) in 2021, flowing through to part of 2022.
- Trade Creditors show as a dramatic reduction from \$60.3k as at the 2020 balance date, down to \$3.4k only at the 2021 balance date. This was largely because, for years now, the City of Wanneroo (CofW) had always required us to pre-book in the prior calendar year, for our upcoming year Kingsway KISS programs, court and room hire, and they would immediately issue us with (prior-year) tax invoices to reflect these bookings (payments were only required in the month before actual bookings). These processed tax invoices largely ended up in the BAWA balance sheet Prepayments account. The CofW has now in 2022 gone to a different software system of accounting for the Kingsway KISS bookings, whereby we no longer are invoiced in advance for the entire year's court hire & room bookings, and tax invoices now only issue in the month preceding the date of the confirmed bookings.
- The financial statements are also significantly impacted by Covid19 pandemic impacts, eg we did not have any state representative teams going to National Events after Jan20 Seniors and Sep/Oct19 U15s. The first National Event we were able to compete at/ enter teams into, after WA & National interstate borders were re-opened in Mar22 was Seniors in Apr22. Normally our balance sheet at calendar/financial year end reflects Senior and U17 deferred revenue (income & expenses), but none of that existed as at 31/12/2021, with borders still closed, and a very late cobbling together of a Seniors team to represent us interstate in early Apr22. Going forward with the re-scheduling of National Under-age Events to later in year timeslots, with the possible exception of the Seniors, these financial impacts on our balance sheet will substantially disappear, under accrual based accounting.
- The balances shown in GST & Payroll liabilities are at balance date inflated by more than one quarter's Business Activity Statements being outstanding at balance date. All outstanding BAS's have since been lodged with the ATO, without penalty except for the General Interest Charge (GIC). The SG payroll liability shown at balance date is current, for one quarter only. SG in 2021 has been remitted when due.

Finally, whilst the association is required by its Rules document (=Constitution) to have adopted Audited Financial Statements at an AGM by end March, the Association is required only to have adopted Financial Statements (reviewed, not audited) under the WA (fairly recent), Associations Incorporations Act 2015, by end June 2021 (within 6 months of balance date). As explained to the AGM 2022 when first convened, due to a number of Covid19 and operational issues, it was not possible for us to have completed Audited Financial Statements for the 2021 calendar year ready by this earlier prescriptive date, nor the statutory date as it turns out. In order to keep within legal requirements, as is permitted under the above referenced Act, BAWA has in Jun22 formally applied to (and paid the requisite fee) to the state Commissioner for Corporate Affairs for a one month's extension to the end Jun22 statutory time limit, and which it fully expects to be granted.

Note 1: Summary of Significant Accounting Policies

Basis of Preparation

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Associations Incorporations Act of Western Australia. In the opinion of the committee the association is not a reporting entity because it is not reasonable to expect the existence of users who rely on the association's general purpose financial statements for information useful to them for making and evaluating decisions about the allocation of resources.

The financial report has been prepared in accordance with the Associations Incorporations Act of Western Australia, the basis of accounting specified by all Australian Accounting Standards and Interpretations, and the disclosure requirements of Accounting Standards AASB 101: Presentation of Financial Statements, AASB 107: Cash Flow Statements, AASB 108: Accounting Policies, Changes in Accounting Estimates and Errors, AASB 1031: Materiality and AASB 1054: Australian Additional Disclosures.

The association has not assessed whether these special purpose financial statements comply with all the recognition and measurement requirements in Australian Accounting Standards.

The financial report has been prepared on an accrual basis and is based on historical costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report.

(a) Income tax

The Association is exempt from payment of income tax under Subdivision 50-A of the Income Tax Assessment Act 1997.

(b) Property, Plant and Equipment (PPE)

Office equipment is carried at cost less, where applicable, any accumulated depreciation.

The depreciable amount of all PPE is depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use.

The depreciation rates used for office equipment is 20%.

(c) Impairment of Assets

At the end of each reporting period, the entity reviews the carrying values of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, is compared to the asset's carrying value. Any excess of the asset's carrying value over its recoverable amount is expensed to the income statement.

(d) Employee Benefits

Provision is made for the association's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits have been measured at the amounts expected to be paid when the liability is settled.

(e) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of six months or less.

(f) Revenue and Other Income

Revenue comprises of grant income (federal, state and local governments), events, registration fees, donations, bank interest, government COVID-19 JobKeeper payment subsidy and Cash Flow Boost instalments and other income.

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

If conditions were attached to the grant which must be satisfied before the association was eligible to receive the contribution, the recognition of the grant as revenue was deferred until those conditions were satisfied.

Revenue from the rendering of a service was recognised upon the delivery of the service to the customer.

Donations were recognised as revenue when received.

Interest revenue was recognised when received.

(g) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the assets and liabilities statement.

(h) Trade and Other Payables

Trade and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the association remain unpaid at the end of the reporting period. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.

(i) Leases

Lease payments for operating leases, where substantially all the risks and benefits remain with the lessor, are recognised as expenses on a straight-line basis over the lease term.

For leases that have significantly below-market terms and conditions principally to enable the association to further its objectives (commonly known as peppercorn/concessionary leases), the company has adopted the temporary relief under AASB2018-8 and measures the right of use assets at cost on initial recognition.

(j) Key estimates and judgments

Employee entitlements - as indicated at Note 1(d), employee benefits have been measured at the amounts expected to be paid when the liability is settled. The association exercises judgment in the classification of employment arrangements in order to assess any obligation for employee entitlements.

Going concern - the COVID-19 pandemic has detrimentally effected the worldwide economy. The association has assessed its ability to continue as a going concern and there is no known material uncertainty as at the date of signing the financial report that would effect the ability of the company to continue as a going concern. Accordingly, the financial statements have been prepared as a going concern.

JobKeeper wage subsidy income – (20FY) this government wage subsidy entitled eligible entities that suffered a specified decline in turnover to a payment of \$1,500 per fortnight for wages paid to eligible employees. Employers elected to participate in the scheme. Employees subject to the scheme must be eligible for JobKeeper payments, with the onus on the employer to establish that all eligibility requirements are met before applying for the scheme. Management exercised judgement in applying for this scheme in the 20FY which was based on future estimates and an employees declaration of eligibility.

(k) Economic Dependence

The association is dependent on government agencies for grant funding. At the date of this report the Committee have no reason to believe these government department's will not continue to support the company.

(l) Reserves

The Court Official Reserve was established to allocate a portion of revenue from tournaments to assist to fund honorariums for volunteers which assist at the tournaments.

The Junior Fundraising Reserve was established to allocate revenue received from parent fundraising activities.

Report on the Audit of the Financial Report

Opinion

I have audited the financial report of The Badminton Association of Western Australia (Inc.) (the association), which comprises the Statement by Members of the Board, the Income and Expenditure Statement, Balance Sheet as at 31 December 2021, Statement of Cash Flows, Statement of Changes in Equity and a summary of significant accounting policies and the certification by members of the board on the annual statements giving a true and fair view of the financial position and performance of the association.

Consistent with the prior year, I do not provide an opinion on the entities eligibility or verify the entitlement in relation to the 20FY Commonwealth Government Jobkeeper assistance.

In my opinion, the accompanying financial report presents fairly, in all material respects, the financial position of the association as at 31 December 2021 and [of] its financial performance for the year then ended in accordance with the accounting policies described in Note 1 to the financial statements and the requirements of the Associations Incorporation Act 2015.

Basis for Opinion

I conducted my audit in accordance with Australian Auditing Standards. My responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Report section of our report. I note that all outstanding BAS's have been lodged with the ATO subsequent to year end. The association has recognised a general interest charge incurred by the ATO to the amount of \$1,429 in the 2021 financial year.

Emphasis of Matter - Contingent liability

I draw attention to Note 7 to the financial report - Contingent liability. This related to an historical matter in relation to allegations of past misconduct of which there is uncertainty relating to the future outcome (if any) of this investigation. My opinion is not modified in respect of this matter.

Emphasis of Matter – Basis of Accounting

I draw attention to Note 1 to the financial report, which describes the basis of accounting. The financial report has been prepared to assist the association to meet the requirements of Associations Incorporation Act 2015. As a result, the financial report may not be suitable for another purpose. My opinion is not modified in respect of this matter.

Independent Auditor's Report to the Members

Responsibilities of the Committee for the Financial Report

The committee is responsible for the preparation and fair presentation of the financial report in accordance with the financial reporting requirements of the Associations Incorporation Act 2015 and for such internal control as the committee determines is necessary to enable the preparation and fair presentation of a financial report that is free from material misstatement, whether due to fraud or error.


