PRESIDENT'S REPORT

I have great pleasure in presenting the 2020 Annual Report for Badminton Western Australia, documenting a challenging and unpredictable year for the Association amidst the Covid-19 pandemic.

Despite the disruptions of lockdowns, cancellations, travel restrictions, and social distancing there were many highlights to celebrate as documented in this report. Thank you to all who have contributed to highlight the achievements of our staff, players, coaches, officials, members and administrators during 2020.



The Board of Management has successfully finalised our Strategic Plan 2021 – 2023 with a Vision for Badminton to become a sport of choice for Western Australians whether competitively or socially. The process included an analysis of our five strategic pillars and their associated tasks and objectives to ensure they remain relevant or determine where they need to be revised and updated. In doing so, we challenged ourselves to seek the best outcome for each goal or action that we set ourselves. Given that we have limited resources at our disposal and rely very much on the goodwill of volunteers and support of our affiliates, there will be many challenges that lie ahead. In delivering this Plan we will promote Badminton as a fun and inclusive sport for people of all ages and abilities with a focus on growing participation and memberships. A full overview of the Plan is on the adjacent page. We look forward to providing strategic direction in the coming months and years and making badminton a popular pastime and competitive activity across our State.

One of the key responsibilities of the Badminton Western Australia leadership is to ensure that our sport remains relevant and visible. This will be greatly advanced by the sport's exciting new brand that features a Badminton Australia master brand replicated for each State or Territory in their individual colours. After a thorough process that included surveys, focus groups and a range of logo concepts, the new brand was finalised and adopted, along with a new positioning line "Let's Play", and the naming of all National teams as The Falcons. You can read more about the new brand in the Marketing report.

I would like to express my gratitude and thanks to my two predecessors Lily Buttrose, who stepped down as President in February 2020 due to ill health, and Eva Wu, who held the role of Acting President and Secretary until October 202 before work commitments led to her having to relinquish her position. I am pleased to report that Lily's health has improved, and she is back coaching again. Eva continues to be a close friend to the sport. Thank you both for your inspiration and guidance. I also wish to thank my colleagues in the Board of Management for their vote of confidence in asking me to take the reins after September.

Finally, I would like to thank all Board members, committees, members and affiliates, volunteers, coordinators, players, parents, coaches, and officials for their on-going support during a very unpredictable year in 2020. As the Covid-19 situation hopefully improves in 2021 and beyond, the strength and resilience we have developed should inspire us to take our sport forwards and make it the first choice for many more Western Australians.

EXECUTIVE OFFICER'S REPORT

All sport, business and our wider community was challenged in 2020 from the COVID-19 pandemic. The strength of Badminton WA and its members however enabled us to manage relatively well. In comparison to our badminton colleagues in the rest of the country and other sports in Western Australia badminton for the most part continued, save for a period of venue closures. The indoor, non-contact, appropriate number of players per meterage rules allowed us to modify our activities at club level. Collaboration between badminton States/Territories and Badminton Australia to develop comprehensive operational guidelines and marketing programs around safe play practices and the return to play program was key to getting clubs back onto court safely, quickly and efficiently. It was important to stay engaged with our members and ensure they all returned to our sport.



Financially, Badminton WA was expecting a challenge with reduced income streams. Whilst our program delivery was reduced many of our core operations continued. We are grateful for the support of the Federal Government's business Cash Boost and Job Keeper programs, as well as several organisations that reduced their charges, including Badminton Australia, Sports Cover and the City of Wanneroo. The Board was pleased to be able to pass much of these savings on to our members.

Our State teams were affected with only one team, our Senior State team, being able to compete at the National Championships. This was a great result for us as we had not had sufficient senior players to enter a Senior team for some years. They performed very well. The U19, U17 and U15 National Championships have each been postponed. Our hosting of the June Bevan Trophy and Australasian U17 Badminton Championships has been postponed and is hoped to be hosted in 2021.

Of the 20 tournaments scheduled to be held in 2020 in the end we were pleased to be able to host 13 tournaments, far more than other badminton State or Territory.

Our para program continues to build its depth and strength. Para categories are now included in each tournament. Coaching courses have been hosted to encourage more support. We have high hopes for two of our elite athletes, Caitlin Dransfield and Grant Manzoney to be selected for Tokyo 2021. Badminton WA participated in several "come and try" and promotional sessions to increase awareness and opportunity for people with a disability to play badminton.





Our very popular and important junior pathway program Shuttle Time Wings, was once again very successful. 10 venues were made available for young players new to our sport. The program, based on school term dates, provides a great skill development base from our qualified coaches. The goal next year will be to develop their tournament level skills and then following that develop relationships with local Clubs to pathway them into nearby clubs so there is the next generation of players.

It was fantastic news for two of our elite players Yiingxiang Lin and Milain Ranasinghe to be selected to represent Australia at the Thomas Cup in Denmark. It was hugely disappointing for this event to be postponed however it showed the strength of our junior development program.



Administratively Badminton WA welcomed our Member Services Event Support Officer, Ashleigh Playle. Ashleigh has brought improved members service and support systems as well as financial controls and information technology to the role. An exciting new membership platform was rolled out to all Clubs. This development will result in improved efficiency, greater ease of clubs to administer their member database and for Badminton WA to have more accurate membership records. Additional modules will be made available in 2021.

Much of 2020 was spent working with Badminton Australia to develop our sport's new image through the "One Brand, One Image" approach which has resulted in a professional new image range that is consistent across all State/Territories and Badminton Australia. This relationship with Badminton Australia is healthy and strong.



Badminton WA has delivered several opportunities to develop a range of officials with courses for coaches, volunteers and umpires. Our future is dependent upon having a strong volunteer and support base.

Badminton WA enjoys great support from the corporate and government sectors and continues to be in a stable financial position. We are grateful for the invaluable assistance of the Department of Local Government, Sport and Cultural Interests (DLGSC), LotteryWest, Healthway, the City of Wanneroo and the City of Mandurah. We work closely with our key stakeholders and have excellent corporate relationships with them.

We look forward to an exciting 2021.

MEMBERSHIP

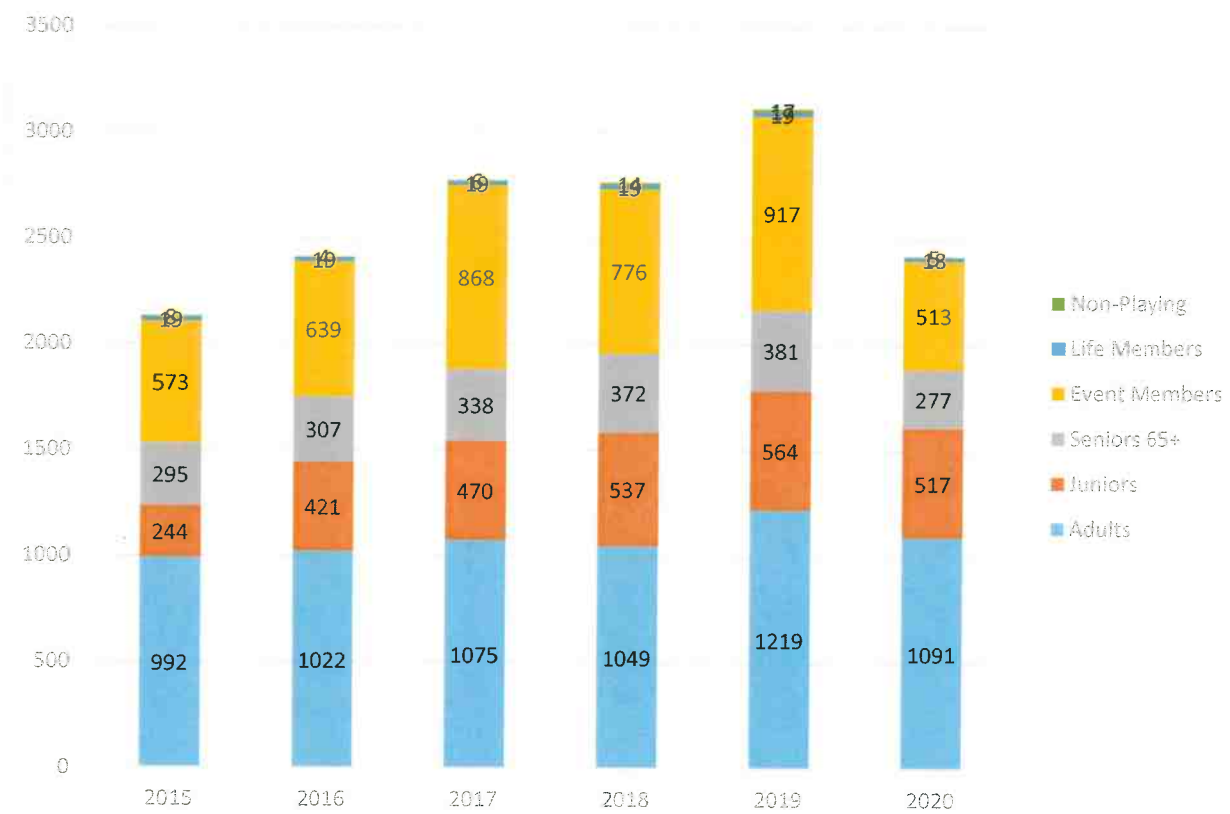
Membership levels for 2020 have been significantly affected by the COVID-19 pandemic.

Up until 2020 there had been a steady growth in membership and participation, with increases in most of the membership categories. There had been encouraging increases in junior membership of Shuttle Time Wings memberships, tournament players and school tournament memberships.



Membership in 2020 saw a 22% reduction in total membership from 3098 to 2415 members. Category membership saw a reduction for Adults, down 10%, Juniors were down 8% whilst Seniors were also reduced by 30%. The cancellation of 5 or more events further reduced event membership levels by 45%. Renewed efforts will be undertaken in 2021 to regain that lost membership base.

MEMBERSHIP – CLUBS AND ASSOCIATIONS

Whilst playing membership were heavily affected most of the Clubs, although taking a break during the lock down periods, continued on once restrictions were lifted.

Each year there is a turnover of Clubs. This is as a result of a range of factors including turnover of office bearers available to manage a club, insufficient retention of members to form a club, closure of venues forcing clubs to relocate as well as the aging demographic of some clubs.

2020 saw 6 clubs discontinue membership, with 6 new Clubs added to the Club list.

INCLUSION AND PARA BADMINTON

In what would prove to be a year like no other, Para Badminton in Western Australia started on a high.

Wheelchair athletes Grant Manzoney (WH2) and Lochan Cowper (WH1) travelled to Ballarat for the 2020 Para Badminton Oceania Championships which were held alongside the able-bodied Oceania Event for the first time.



This gave Para Badminton great exposure and both players were successful in winning their respective singles events and teaming up to win the doubles event.

For Grant, this was his 2nd Oceania singles and doubles title after winning both in 2018 and for Lochan, his first title in both events.



Para athletes Caitlin Dransfield and Grant Manzoney had their Paralympic aspirations put on hold when the announcement was made to postpone the Paralympic Games for 12 months.

Both players are working tirelessly both on and off the court in the hope of qualifying for the games later this year.

All 3 athletes finished the year inside the top 20 in the World Rankings in their respective classifications.

In 2020, Badminton WA lead the way by incorporating Wheelchair events into the state tournaments which are open to all players to enter.



This saw many able-bodied players jump into the chairs to not only challenge our Para players but to also gain an insight into how difficult it can be.

A High Performance Squad was developed under the direction of High Performance Manager Ryan Lin. This saw several talent players being developed to the next level of performance.

Bad Wheels continues to run every Thursday night with an increase in player numbers and we thank coach Mark Cunningham for his dedication to running this program.

Several "Come and Try" and "Introduction to Para" days were hosted by Badminton Australia National Disability Services Manager Ian Bridge, often in conjunction with a tournament, so that new players could feel and experience what the sport is all about. Introduction coaching courses were also conducted to encourage more coaches to be available work with athletes with a disability.

REGIONAL DEVELOPMENT

Western Australia badminton is well supported in our regional areas. 2020 saw 13 clubs deliver badminton opportunities to players in country regions. It was a difficult year, with the opportunity to undertake activities restricted until mid-2020. Some of the activities undertaken in the second half of the year.

These 13 Clubs managed to host regular pennant competitions for a range of groups from tiny beginners, to school competitions, to men and women adults as well as to senior groups.



2020 saw Badminton WA support these efforts with trips to towns such as Christmas Island, Geraldton, Bunbury, Mandurah and Cunderdin to deliver coaching and school opportunities, to grow the game and support the local volunteers in those areas.

The City of Mandurah LiveLighter South-West Championships is a well established event on the calendar and was

successfully hosted at the Mandurah Aquatic and Recreation Centre. We were sorry to have to cancel the 2020 Country Carnival as a result of COVID-19. A 'come and try' opportunity provided for potential para-badminton players during the Mandurah tournament in September.



Our Sporting School program took coaches into the country to centres such as Djiji Djiji Aboriginal School Bunbury, Balingup Primary, Mount Barker Community College and Newton Moore SHS Bunbury. We also supported once again the hosting of the LiveLighter WA District High School Country Week.



National Disability Manger Ian Bridge undertook a special trip to Christmas Island for coaching sessions with the local club and school groups. Ian discussed put in place plans to formalize the Club and to return in 2021.

Plans are being developed to conduct Shuttle Time Wings coaching courses in Bunbury and Geraldton in 2021. Badminton WA supported Bunbury and Districts Badminton Association in hosting the Bunbury open.

Coaches from Geraldton and Districts badminton Association attended the BWF Level1 Coaching course held in Perth. The aim is to develop the coaching expertise in regional centres to meet the growing demand, especially from our younger members.

Thank you to everyone who organized or contributed to activities for regional areas in 2020.

JUNIOR DEVELOPMENT

The Badminton WA Junior Development Program consists of several different aspects that are operated through different formats and approaches, often incorporated or alongside other participation and development initiatives.

As it was a COVID-19 affected year, some of the junior tournaments and competitions were cancelled during the March – July period.

School Clubs and Training

School clubs evolve through various initiatives such as ATAR school-specific ex-curricular training, Badminton WA School Tournaments, Shuttle Time Wings Program, inter-school carnivals, and direct services from private coaches.

Most school clubs / groups operate independently. Some schools directly hire the services of coaches recommended by Badminton WA. Most of these clubs are not affiliated, except for those within the Wings Program.



School Tournaments

4 school tournaments were scheduled in 2020, however only 2 school tournaments (middle school tournament) were carried out only after sports were permitted to resume activity from the affected COVID-19 pandemic, and the tournaments were attended by 108 players from schools for the first middle school tournament and 128 players from schools for the second middle school tournament.



School Sport WA advertised the tournaments and sent a representative to help at the event.

LiveLighter WA District High School Country Week

Badminton WA successfully managed the badminton component of this five-day School Sport WA event for the eleventh consecutive year. The number of schools participated in the event was significantly reduced as a result of COVID-19.

Schools that had participated in the carnivals were Dalwallinu DHS, Dongara DHS, Geraldton Grammar, Gnowangerup DHS and Kulin DHS.

Shuttle WINGS Programs

The Wings Program has been successfully run for a fifth year. Ten Wings junior clubs operated in Perth throughout 2020 with more than 250 members training and playing weekly.

More Wings players have attended mainstream Badminton WA sanctioned tournaments. However, the challenge remains in transiting the WINGS players from the program to a club as there are currently no established junior clubs for that.



Junior Tournament Participation

Nearly every Badminton WA tournament has featured a junior division. Junior players from the WINGS clubs, WA Under-15 High Performance squad and the Combined Under-17 & Under-19 High Performance squad, State team players, as well as participants from inter-state and overseas have entered and played in our tournaments.

Many of WA juniors competed well both partnering and against the adult players.

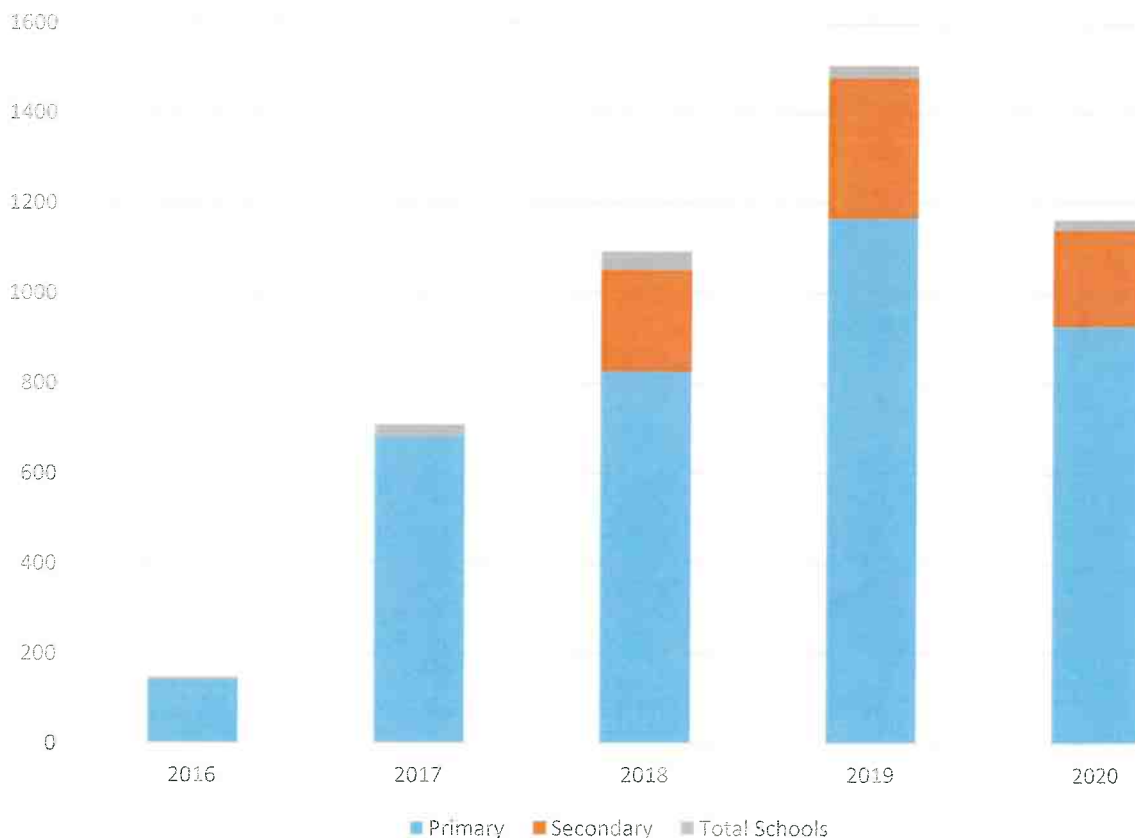
Sporting School

Sporting Schools is a federal government funded program which provides primary and secondary schools with access to funds to use for group sports coaching. Badminton has been part of the program since its inception in 2016. Programs range in number from 4 - 10 sessions, with students aged between 6-13 being introduced to the sport in the school. Badminton WA provides all the required equipment.



In 2020, 20 schools had badminton sessions for their students: Term 1: 4 schools (203 students); Term 2: 1 school (25 students); Term 3: 6 schools (249 students) and Term 4: 12 schools (674 students).

HIGH PERFORMANCE

The Badminton WA High Performance in the year 2020 continued on the focus of the junior development, having included a combined U17/U19 High Performance squad to ensure that junior players in that age group are also provided with regular training and sparring sessions. 2020 turned out to be a challenging year with COVID affecting the daily lifestyles of everyone and affecting all corners of the sporting industry. Many planned high performance programs had to be readjusted or even cancelled due to restrictions.

The Under 15 age group squad had 18 juniors in the program, with the appointment of 2 head coaches and 2 assistant coaches, and the newly formed Combined Under 17 and Under 19 age group squad had 20 juniors in the program, with an appointment of 1 head coach and 1 assistant coach. The high performance program only commenced in the second half of 2020 (August) for a total of 16 weeks. The high performance squad could not have been made this far without the tremendous effort from our coaches and The Board of Management of Badminton WA would like to take this opportunity to thank and acknowledge all coaches for their dedication, efforts and time spent training and developing the young badminton talents in Western Australia.

The coaches and assistant coaches are as follows: Head Coach – Yuli Zheng (u17/u19), Nick Kidd and Jasper Tan (U15); Assistant Coach – Eric Low (U17/U19), Angie Yang and Edmund Xu (U15).

In 2020, WA continued to produce a number of young junior badminton talents who were selected into Badminton Australia's 2020 National Junior Squad (Elite): Julian Lee and Bernice Teoh. Timothy Sentosa and Joanne Zheng were also selected into the Badminton Australia's 2020 National Junior Squad (Development).

The high performance program continues to grow and change, and we had to adapt as a new pathway was developed and established from Badminton Australia in 2020 and will be put into action in 2021. Changes were updated through the Badminton Australia website and was also reflected in our Badminton WA High Performance program.

Moving forward the combined High Performance Squad U17 and U19 group will continue to build the foundations for the Senior and also to provide a better training environment (coaching personnel, equipment and training strategies) to better develop the junior players.

In the next year, we hope to improve in the program by including more specific training regimes focusing more on the Doubles and Mixed Doubles on top of the usual training structure. We hope to achieve even greater success with developing the junior program for 2021.

As the national championships were majorly affected in 2020, it was fortunate that the seniors were still able to proceed in the early months (January/February). The U17, U19 and the U15 were called off for the 2020 season.

COACHING

In 2020 the Coaching Development program included:

- * Provision of coaches for State Teams, High Performance squads, Sporting Schools sessions, Wings Clubs, groups & individuals.
- * Overseeing a BWF Level 1 Coaching course
- * Organising a Shuttle Time Teachers course
- * Providing a direct link from the website to the Coaching Coordinator for all queries regarding the provision of coaches and courses etc.



BWF LEVEL 1 COACHING COURSE

This course was subsidised by the Oceania Badminton Confederation, so cost to candidates was reduced to \$50. The course was held across two weekends: 19-20th September, 14-15th November.

Tutor: Ian Bridge. Assessing assistance provided by Ryan Lin. Sixteen (16) candidates completed the course with seven (7) passing, eight (8) receiving provisional passes and one (1) failing. The eight with provisional passes completed extra coaching work and re-assessment in February.

BWF SHUTTLETIME COURSE

A course was held on the 21st November. Tutor: Ali Courtie

Ten (10) candidates completed the course with five (5) passing, four (4) receiving provisional passes, and one (1) failing. Those with provisional passes have been provided with mentoring advice and opportunities to reach the required standard.



DEPARTMENT of LOCAL GOVERNMENT SPORT, CULTURAL INDUSTRIES FORUM

This Strategic Planning Coaching Forum was held in August and attended by Badminton WA Coaching Coordinator, Judith Cousins, and Coach, Anita Diep.

NATIONAL CARINVALS

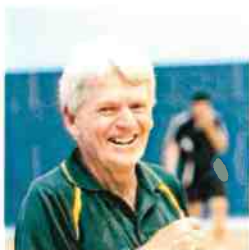

FACILITIES

The Kingsway Indoor Stadium continues to be our premier venue for badminton in Western Australia. The venue, located in Madeley and managed by the City of Wanneroo, houses our administrative centre, the venue in which we host the majority of our events as well as the location of our support equipment required for tournaments.



Kingsway Indoor Stadium is perfect for hosting small to large tournaments and events. With great support from the City of Wanneroo badminton is able to have a professional home to operate from.

With the growth in competition numbers and the geographical diversity of our competition membership 2020 saw a focus on building relationships with new stakeholders in order to meet the demand for facilities and to develop an essence of bringing the sport to the people and not the other way round. As such discussions have commenced with a range of venues to gain access to the facilities and in some cases discussions regarding the upgrade of existing facilities. These discussions include City of Armadale, City South Perth, City of Wanneroo, City of Joondalup as well as the City of Swan.

2021 will see a conscious effort to host more tournaments, promotions, coaching and other courses in the south of the river locations at locations such as Perth Badminton Arena and Armadale Badminton Centre.

Planning and bookings have been made to broaden the venues we use across our programs including Shuttle Time Wings, Coaches course, Para Development squad training, High Performance training as well as to our regular tournament venues.

MARKETING AND COMMUNICATIONS

A New Look

One of the highlights of 2020 was the adoption of a single brand for the sport of Badminton across Australia, bringing our sport in line with other codes such as tennis, cycling, squash and triathlon, amongst others. The new brand was developed through a “One Message, One Brand” working group convened by Badminton Australia with representatives from State and Territory associations as members. The new brand, which is shown on this page, was presented to the BA Board and State and Territory associations in the latter part of the year and given their unanimous approval. A new tagline or call to action “Let’s Play” was also accepted as was the name of The Falcons – inspired by the Peregrine Falcon which is native to Australia - for all Badminton National teams. Badminton WA has begun updating its collateral with the new logo, which is already used on our newsletter and social media and will be phased in on other channels in the coming months.

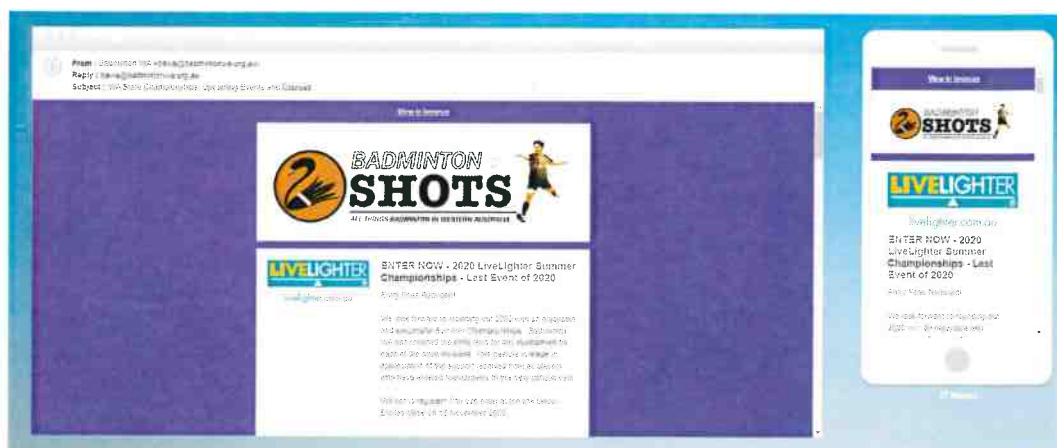
Strategic Communications workshop

2020 also saw the Board of Management taking part in a Strategic Communications Workshop with the purpose of confirming our Vision, Mission, Values and Core Purpose to ensure that our marketing and communications efforts are consistent, professional and outcomes focussed. Spreading the Badminton message

As in 2019, our marketing and communications was focused on our E-Newsletter, which was given a fresh new layout, website, and social media channels, including Facebook, Instagram and YouTube. We have made fantastic progress with our Facebook page during 2020 despite the challenges posed by Coronavirus, which forced the cancellation of tournaments and placed restrictions of participation and attendance at events. The Facebook page, which now has more than 2,500 followers, has been important to helping us keep our members and fans up to date in these challenging times and it continues to go from strength to strength. We have also set up an Instagram page and will be developing a strategy on how best to utilise this channel moving forward.

The "Badminton Shots" e-newsletter remains crucial to our aim to communicate important information regarding governance matters, coaching and umpiring courses, tournaments, training camps, and other events as well as general news. We have continued to use live streaming via YouTube at some of our tournaments but in a Covid-19 disrupted year this has not always been possible, and we are investigating how we can make this a regular feature going forward.



Finally, the BAWA website is an important channel for information regarding events and programs as well as the 'go-to' destination for people wanting info on clubs and associations, memberships, coaching and development programs and much more. Given its importance we will be embarking on an initiative to upgrade the website in near future to ensure that it continues to be a valuable source of information to our members and supporters.

Note 1: Summary of Significant Accounting Policies

Basis of Preparation

This financial report is a special purpose financial report prepared in order to satisfy the financial reporting requirements of the Associations Incorporations Act of Western Australia. In the opinion of the committee the association is not a reporting entity because it is not reasonable to expect the existence of users who rely on the association's general purpose financial statements for information useful to them for making and evaluating decisions about the allocation of resources.

The financial report has been prepared in accordance with the Associations Incorporations Act of Western Australia, the basis of accounting specified by all Australian Accounting Standards and Interpretations, and the disclosure requirements of Accounting Standards AASB 101: Presentation of Financial Statements, AASB 107: Cash Flow Statements, AASB 108: Accounting Policies, Changes in Accounting Estimates and Errors, AASB 1031: Materiality and AASB 1054: Australian Additional Disclosures.

The association has not assessed whether these special purpose financial statements comply with all the recognition and measurement requirements in Australian Accounting Standards.

The financial report has been prepared on an accrual basis and is based on historical costs and does not take into account changing money values or, except where specifically stated, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless otherwise stated, have been adopted in the preparation of this financial report.

(a) Income tax

The Association is exempt from payment of income tax under Subdivision 50-A of the Income Tax Assessment Act 1997.

(b) Property, Plant and Equipment (PPE)

Office equipment is carried at cost less, where applicable, any accumulated depreciation.

The depreciable amount of all PPE is depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use.

The depreciation rates used for office equipment is 20%.

(c) Impairment of Assets

At the end of each reporting period, the entity reviews the carrying values of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, the recoverable amount of the asset, being the higher of the asset's fair value less costs to sell and value in use, is compared to the asset's carrying value. Any excess of the asset's carrying value over its recoverable amount is expensed to the income statement.

(d) Employee Benefits

Provision is made for the association's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee benefits have been measured at the amounts expected to be paid when the liability is settled.

(e) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of three months or less.

(f) Revenue and Other Income

Revenue comprises of grant income (federal, state and local governments), events, registration fees, donations, bank interest, government COVID-19 JobKeeper payment subsidy and Cash Flow Boost instalments and other income.

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

If conditions were attached to the grant which must be satisfied before the association was eligible to receive the contribution, the recognition of the grant as revenue was deferred until those conditions were satisfied.

Revenue from the rendering of a service was recognised upon the delivery of the service to the customer.

Donations were recognised as revenue when received.

Interest revenue was recognised when received.

(g) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the assets and liabilities statement.

(h) Trade and Other Payables

Trade and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the association remain unpaid at the end of the reporting period. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.

(i) Leases

Lease payments for operating leases, where substantially all the risks and benefits remain with the lessor, are recognised as expenses on a straight-line basis over the lease term.

For leases that have significantly below-market terms and conditions principally to enable the association to further its objectives (commonly known as peppercorn/concessionary leases), the company has adopted the temporary relief under AASB2018-8 and measures the right of use assets at cost on initial recognition.

(j) Key estimates and judgments

Employee entitlements - as indicated at Note 1(d), employee benefits have been measured at the amounts expected to be paid when the liability is settled. The association exercises judgment in the classification of employment arrangements in order to assess any obligation for employee entitlements.

Going concern - the COVID-19 pandemic has detrimentally effected the worldwide economy. The association has assessed its ability to continue as a going concern and there is no known material uncertainty as at the date of signing the financial report that would effect the ability of the company to continue as a going concern. Accordingly, the financial statements have been prepared as a going concern.

JobKeeper wage subsidy income – this government scheme is a wage subsidy that entitles eligible entities that have suffered a specified decline in turnover to a payment of \$1,500 per fortnight for wages paid to eligible employees. Employers elect to participate in the scheme. Employees subject to the scheme must be eligible for JobKeeper payments, with the onus on the employer to establish that all eligibility requirements are met before applying for the scheme. Management exercises judgement in applying for this scheme which is based on future estimates and an employees declaration of eligibility.

(k) Economic Dependence

The association is dependent on government agencies for grant funding. At the date of this report the Committee have no reason to believe these government department's will not continue to support the company.

(l) Reserves

The Court Official Reserve was established to allocate a portion of revenue from tournaments to assist to fund honorariums for volunteers which assist at the tournaments.

Report on the Audit of the Financial Report

Opinion

I have audited the financial report of The Badminton Association of Western Australia (Inc.) (the association), which comprises the Statement by Members of the Board, the Income and Expenditure Statement, Balance Sheet as at 31 December 2020, Statement of Cash Flows, Statement of Changes in Equity and a summary of significant accounting policies and the certification by members of the board on the annual statements giving a true and fair view of the financial position and performance of the association.

Consistent with the prior year, the audit did not include the accounts related to Travel Cards. In addition, I do not provide an opinion on the entities eligibility or verify the entitlement in relation to the Commonwealth Government Jobkeeper assistance.

I draw attention to Note 1(j) to the financial report, which describes the critical accounting estimates and management judgement exercised in relation to the government JobKeeper wage subsidy. The eligibility for the scheme is based upon management judgement and employees declaration of eligibility. My audit does not include an opinion in relation to eligibility for this scheme. My opinion is not modified in respect of this matter.

Emphasis of Matter – Basis of Accounting

I draw attention to Note 1 to the financial report, which describes the basis of accounting. The financial report has been prepared to assist the association to meet the requirements of Associations Incorporation Act 2015. As a result, the financial report may not be suitable for another purpose. My opinion is not modified in respect of this matter.

The financial report of the association for the year ended 31st December 2019 was audited by another auditor who expressed an unmodified opinion on that financial report on 20th March 2020.
