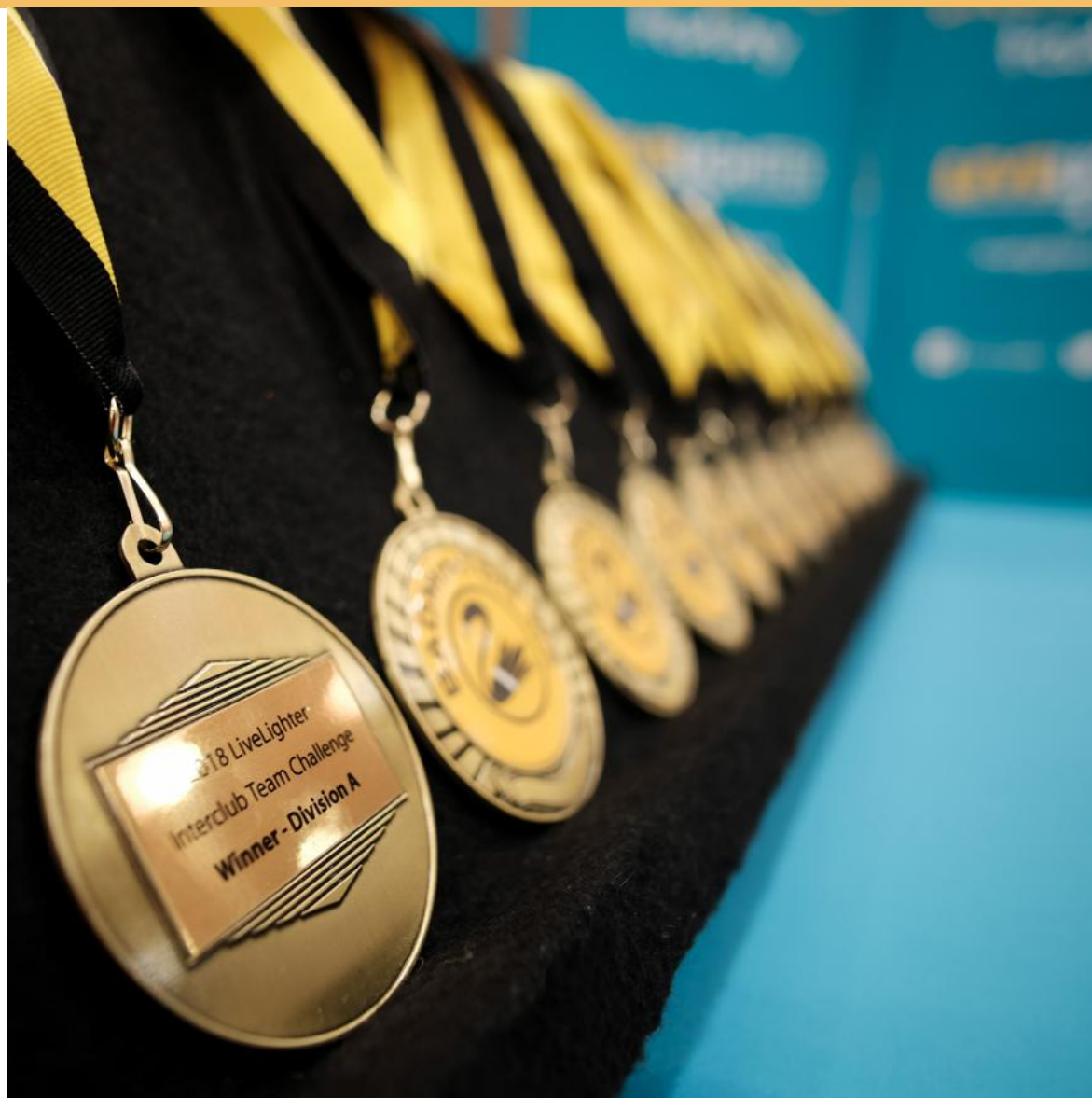

PRESIDENT'S REPORT

The “seas of change” of 2018 have been constant in presenting challenges to Badminton WA. However, where challenges reside, new opportunities would also evolve.

Organisation and Governance

We continued to cooperate well with our government and industry stakeholders.

The Association set on a fresh new start with the Strategic Plan for 2018 – 2020, the updated Constitution compliant to new Associations Incorporation Act, and a full Board with the re-nomination of the experienced and knowledgeable Kim Rodgers; the methodical and organised Eva Wu as our new Secretary; and Samuel Fan, who aspired to take our marketing and sponsorship to another level.

Samuel Fan resigned in June after exploring the area of engaging external consultant for sponsorship promotion. Preetham Namaskumar resigned in July. His efforts were dedicated to identify improvement plan on organisational capacity building. I thank both gentlemen for giving the consideration to volunteer as Board members and for their genuine intention and efforts to make a difference for the Association.

Neal Miranda, our Treasurer and Vice President, worked to keep Risk Management and Volunteer policies reviewed in addition to doing the monthly financial review; Kim Rodgers continued to provide valuable insights and support

on sports administration to ensure continuity; Eva Wu took to lead

on updating policies and procedure while inputting extraordinary effort and energy into the growing amount of Board activities and projects well outside the normal remit of the Secretary, in volunteering at events and club; Mark Cunningham continued to plough through the events calendar to ensure tournaments are run smoothly and made enjoyable for the players, making improvements along the way. Ryan Lin continued to try and keep the high performance and coaching portfolio on track while being busy with his study and work commitments. Janet Spellissy was invited to fill a casual vacancy and officially joined the Board in October, taking on the marketing and sponsorship portfolio.

Our committee chairs and coordinators have done an amazing job to keep the various organisational functions operating in order. However, it has become apparent that some areas are stretched with resources.

In a time of transition and increasing workload, we must also address staff and volunteer development, retention and succession which remains challenging territory given the Association’s financial and human resources reality.

Participation and Development

We continued to be fully committed to grassroots participation through the increasingly popular Wings programme in the communities and Sporting Schools programme at schools.

Whilst plans were in place to expand the high performance squad to include junior players of wider age groups. Lack of availability of coaches and capacity has hindered the implementation.

Several coaching courses were planned and run, to conform to the new national coaching education and accreditation framework, covering Shuttle Time, Badminton Australia Level 1, and BWF Level 1. Details are reflected in this Annual Report under operational business.

There remains the challenge of matching players development pathway with the coaches development pathway in planning and implementation. This calls for a different approach to how we train and maintain the coaching “working force” to meet the demand of the needs of players at various developmental stages.

Facilities

We have maintained good relationship with all venues where our clubs and programme are located. We are up-to-date with our understanding of venues with badminton courts on offer and continue to provide this information to enquiries.

We continued to explore opportunities with key stakeholders such as councils, other sports, developers, and consultants to identify feasible option towards a state badminton facility.

We reached out to our member associations to provide support in maintaining the current facility and investigating development prospects.

Congratulations go to our Bunbury Association for the determined efforts in fundraising to upgrade the facility with proper playing mats - a winning point for attracting a record participation in the Bunbury Open.

Events and Tournaments

Badminton WA aims to host at least one national or international event each year. We planned an extensive mix of tournaments and worked to deliver each event to our best standard.

This was ensured through the Association’s long term commitment in building strong event management capability. We had sent key organising personnel to Badminton Oceania Event Management courses for the 2018 Australian Junior International and 2019 Perth International.

Tournament planning is a time consuming job largely taken up by staff. Small-scale training sessions were therefore offered locally to help people with an interest learn about Tournament Software.

Badminton WA Technical Officials have a reputation of high standard at the national and international events. The Committee actively conducted courses and assisted officials and candidates to improve through working in tournaments. Jiten Bhatt was nominated and won the RAC WA Sports Star Award as the Official of the Year, making Badminton the sport which was given the same award two years in a row!

We were successful in bidding for a BWF Future Series event in 2019, the inaugural Perth International, through which we aim to attract more international players in the years to come.

Marketing and Communications

This has traditionally taken up a lot of staff time to develop and manage on an ad hoc basis.

With a newly appointed Board member dedicated to marketing and sponsorship

as a portfolio, a committee would need to be re-instigated to work with the staff in adopting more strategic and structured approaches to develop a communications plan, and marketing materials and methods to promote badminton and help secure sponsorships.

The outcome of our work in membership service, junior high performance, tournaments, junior clubs, coaching, school programme, para-badminton, and technical officials are reflected in details within this Annual Report. I would like to thank all staff, our members and volunteers for the continuous contributions and diligence to help us achieve so much!

Let's gear up into 2019, a year with so much to unveil.

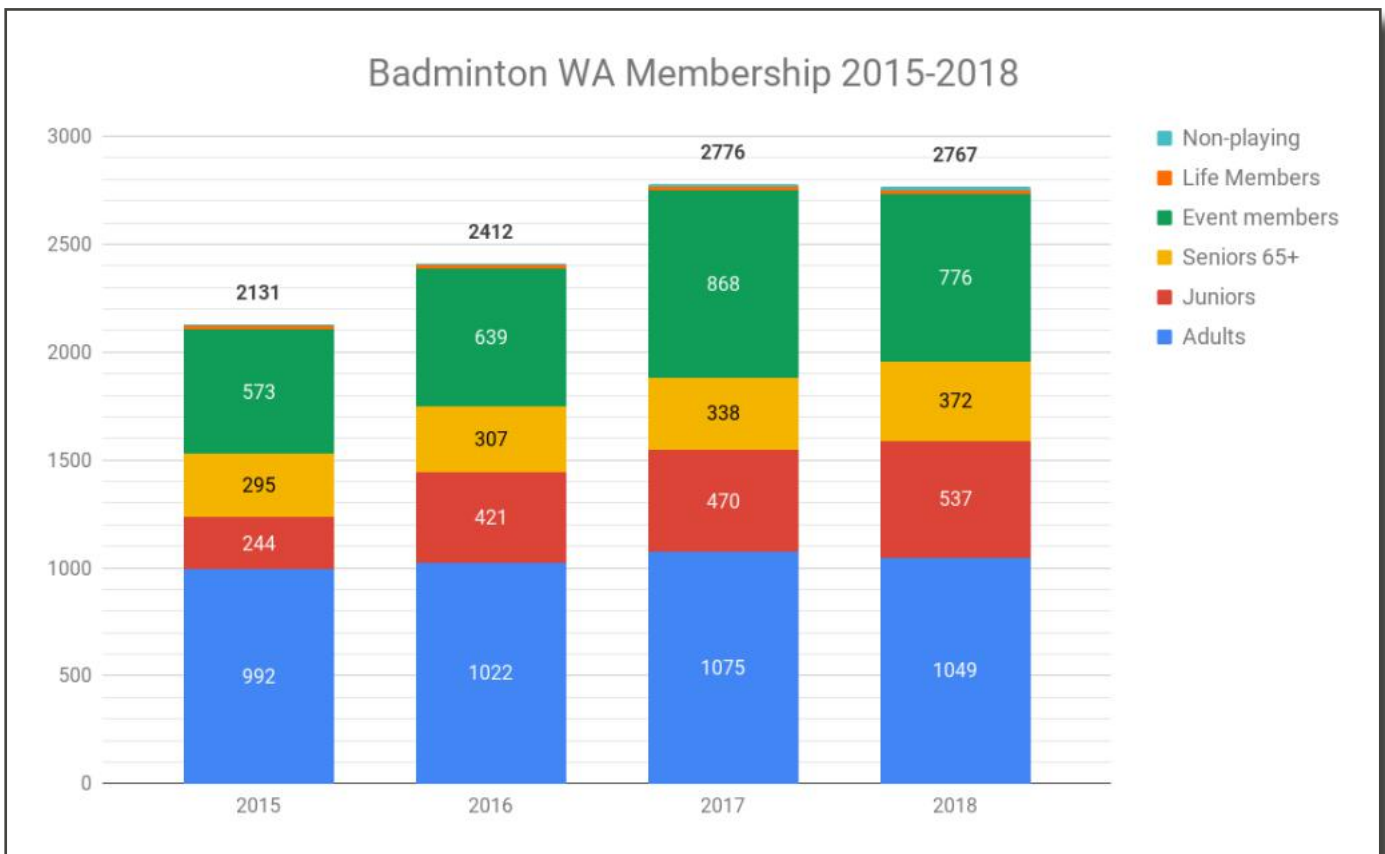

Membership - Players

Membership has remained stable in 2018 compared to 2017, with a slightly higher number of tournament players choosing to become full members rather than be charged event membership fees for every tournament they play. This can actually be seen as a hidden increase since the event membership numbers allow "double count" for those entering multiple events.

Encouraging growth in juniors continues, partially thanks to our Wings Junior Programme, and partially due to some new clubs that have joined us with a significant junior contingent. Senior (65+) membership also continues to grow; it appears that the "middle cohort" of adults of working age are somewhat less active in joining and supporting local clubs.

Membership - Clubs and Associations

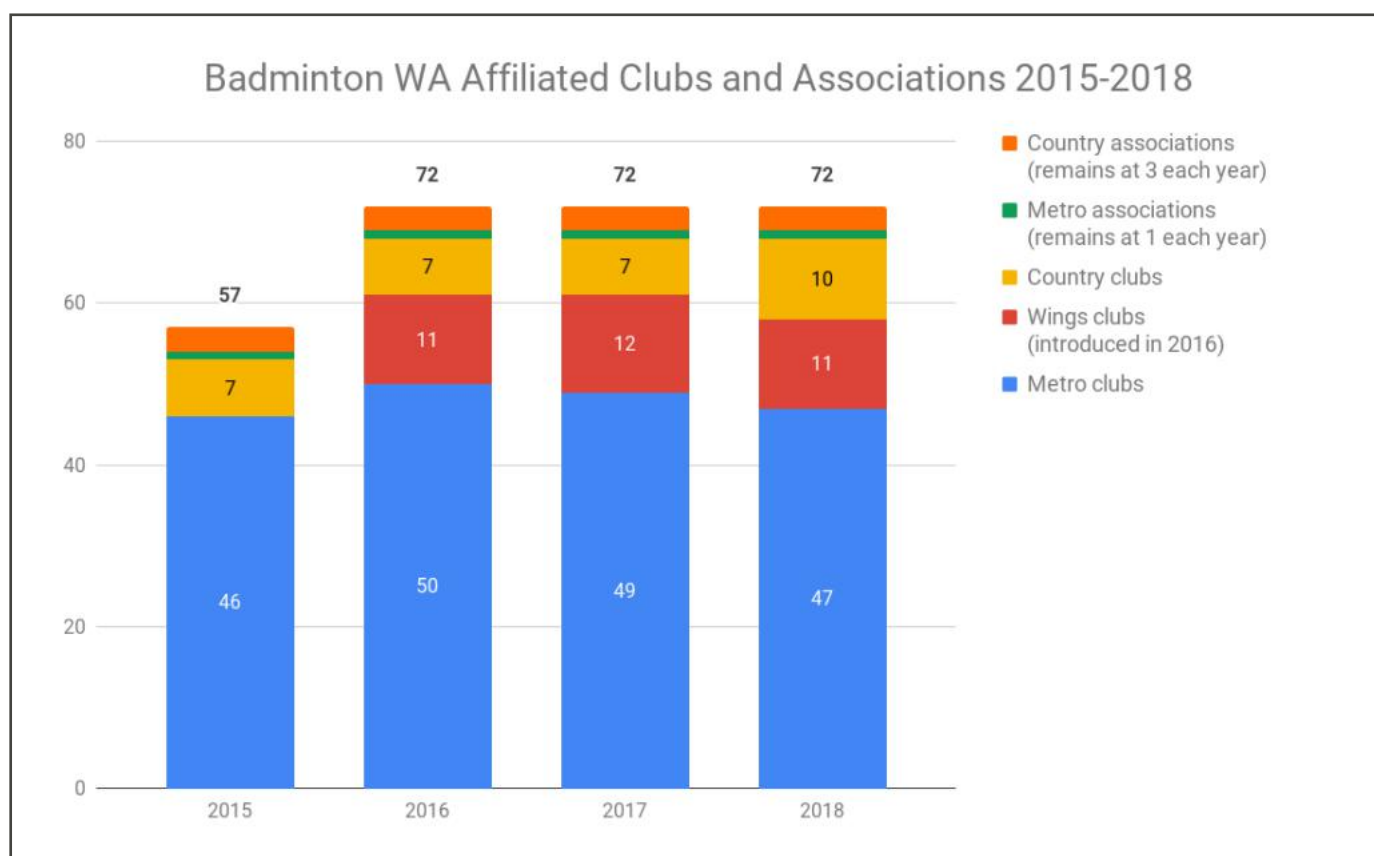
Our 4 affiliated associations - Bunbury & Districts, Geraldton & Districts, Eastern Goldfields, and South Suburban - have maintained their affiliation status with us, despite a number of challenges that they are facing with only very limited funding available to the regions and also the difficulties of attracting and retaining members and committee volunteers.

The number of affiliated clubs has also been stable (68 clubs) compared to last year; a small handful of clubs lapsed their affiliation in 2018, but also several new (or

"renewed") clubs - both Metro and Country - have affiliated with Badminton WA.

The network of Badminton WA's Wings Junior Clubs has currently stabilised at 11 clubs, covering both North and South of the River areas of Perth.

Several of our incorporated clubs have commenced and/or completed important work of ensuring compliance with the new Associations Incorporation Act 2015, and we have provided them with our assistance where possible.

Inclusivity and Para-Badminton

In February 2018 Badminton WA together with Badminton Australia have co-hosted the Li Ning Australian Para-Badminton Championships, held at the Kingsway Indoor Stadium. The event was attended by 21 athletes in all para-badminton classes except SU5. The event was followed by a training camp for tournament players and an open come-and-try session.

Reduction in inclusivity- and para-badminton related funding made it challenging to maintain the same level of para-badminton initiatives as in the three previous years. Our Inclusivity Officer Ian Bridge has tendered his resignation in June 2018, largely caused by this reduction in available funding. Nevertheless, a number of inclusivity-related activities continued throughout the year, introducing the sport to a variety of participants of different ages and abilities. One of such activities was organised in Bunbury with support from the local Bunbury & Districts Badminton Association, a commendable initiative on their part which we hope will open new participation opportunities to a number of people in that region.

Caitlin Dransfield is the only WA para-badminton player (or, for such matter, the only WA badminton player in history so far) who has received a Western Australian Institute of Sport scholarship to support her development towards very ambitious goals on the national and international para-badminton scene in 2019-2020. This year Caitlin has claimed Oceania's singles and mixed doubles title in the standing para-badminton class, as well as the

National title in singles and a number of silver and bronze medals in other events.

Grant Manzoney is another WA para-badminton athlete who has made very impressive progress in the last couple of years, and is currently the reigning Australian and Oceania champion in wheelchair singles (WH2 for Oceania) and men's doubles. Grant also has a number of important international events coming up in the lead-up to Tokyo 2020 where para-badminton will be making its Paralympic debut.

Junior Development

The Badminton WA Junior Development Programme consists of several different aspects that are operated through different formats and approaches, often incorporated or alongside other participation and development initiatives.

School Clubs and Training

- * School clubs evolve through various initiatives such as ATAR school-specific ex-curricular training, Badminton WA School Tournaments, Wings Programme, inter-school carnivals, and direct services from private coaches.
- * Most school clubs / groups operate independently. Some schools directly hire the services of coaches recommended by Badminton WA.
- * Most of these clubs are not affiliated, except for those within the Wings Programme.

School Tournaments

- * Four termly tournaments were attended by 550 players from schools.
- * School Sport WA has advertised the tournaments and sent a representative to help at each event.

WA District High School Country Week

- * Badminton WA successfully managed the badminton component of this five-day School Sport WA event for the tenth consecutive year.
- * BWF Shuttle Time and teaching resources were introduced to district high school teachers during the event.

Wings Programme

- * The Wings Programme has been successfully run in its 3rd year. 11 Wings Junior Clubs operated in Perth throughout 2018 with more than 240 members training and playing weekly.
- * Wings Team Challenge was successfully held on 1st July with 60 players.
- * More Wings players have attended mainstream Badminton WA sanctioned tournaments.

Junior Tournament Participation

- * Nearly every Badminton WA tournament has featured a junior division. Juniors players from the Wings Clubs, WA Under 15 High Performance Squad, State Team players, as well as participants from inter-state and overseas have entered and played in our tournaments.
- * Many of WA juniors competed well both partnering and against the adult players.

High Performance

The Badminton WA high performance programme in 2018 once again focused on the Under 15 age group squad. This successful programme is headed by a very experienced coach Yuli Zheng, and once again its participants and graduates have dominated the award podiums of the majority of our junior competitions. In 2018 the WA Under 15 High Performance Squad has consisted of 14 competitive and talented young players. These youngsters benefit immensely from training together, which also helps form a strong bond between them, essential in the team competition situations.

The Board of Management of Badminton WA takes an opportunity to thank and acknowledge Ms. Yuli Zheng for her dedication, efforts and time spent training and developing the young badminton talents in Western Australia. We also would like to acknowledge Mrs. Annie Sim - the High Performance Programme Coordinator - for all her hard work in 2018.

State team results and individual national titles claimed by WA players are listed in the State Teams section on page 20 of this report. Unfortunately, due to low interest, Badminton WA was once again unable to field a team in the national Senior Carnival.

Continuing the tradition of WA producing young badminton talents, a number of juniors have been selected into Badminton Australia's 2018 National Junior Squads: Theodore Kang, Bernice Teoh and Hong Yuan Wong were part of the U17 Youth Development Squad, while Kai Chen Teoh was selected into the U19 Elite Development squad.

One of the highlights was the selection of Kai Chen Teoh to represent Australia at the TOTAL BWF Thomas Cup Finals in Bangkok in May; an achievement to be proud of for a player who was still 17 y.o. at the time of this top class open age team event. Kai Chen has also represented Australia in the LI NING BWF World Junior Championships in Markham, Canada in November where he was the Australian team captain.

Another WA player, Daniel Fan, has entered and participated in multiple international events and as a result has achieved the position of the highest ranked Australian men's singles player according to BWF rankings and maintained it for the most of the second half of 2018.

Coaching

In 2018 the coaching programme and activities included:

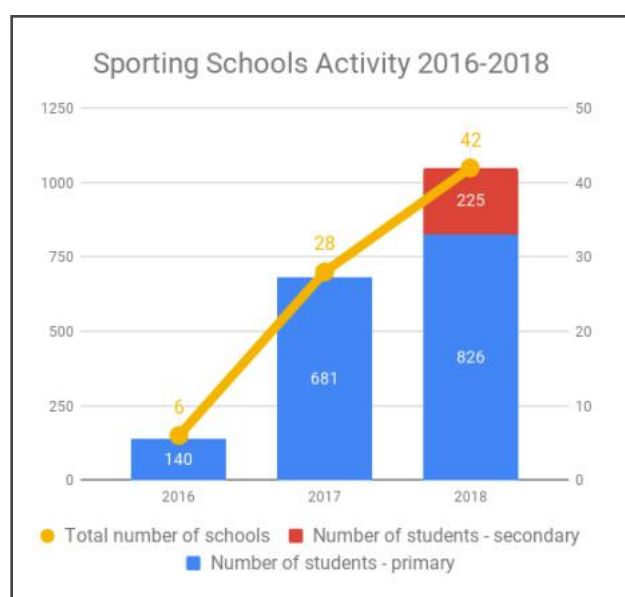
- * Provision of coaches for State Teams, High Performance squads, Sporting Schools sessions, Wings Clubs, groups and individuals.
- * Facilitating the first BWF Level 1 coaching course to be held in WA in two 2-day sessions (May and August 2018), presented by Ian Bridge and Robbie Thackham. 10 candidates have successfully completed the course and achieved this international qualification. Subsidies have been offered to course participants thanks to funding from the Department of Local Government, Sport and Cultural Industries.
- * Organising two BA Level 1 Coaching courses (May and November 2018), presented by Kay Terry. 16 candidates have successfully achieved this national qualification level.
- * Organising one ShuttleTime Teacher course (August 2018), presented by Lily Buttrose. 4 participants have achieved this entry level/grassroots internationally recognised qualification.
- * Organising two coaching forums (June and November 2018), providing coaches with Coach Development Activity points.
- * Organising one regional coaching trip (York), with a variety of coaching activities delivered by Kay Terry.
- * Subsidising one para badminton athlete to achieve a national coaching qualification.
- * Providing a direct link from the website to the Coaching Coordinator for all queries regarding the provision of coaches, courses and professional development, etc.

Sporting Schools

Sporting Schools is a federal government funded programme that enables primary and (from 2018) secondary schools to access funding and provide group sports coaching to their students. Badminton WA remains very active in this area, ranked second among all Australian states by number and reach of programmes delivered. This area of Badminton WA activity is coordinated by Kay Terry, and 11 qualified coaches were involved in the delivery of school badminton sessions in 2018.

Badminton WA technical officials had an impressively busy year: an extensive line-up of local tournaments (including a BWF-sanctioned Australian Junior International), 3 WA State Teams, some spectacular international events - from Commonwealth Games in Gold Coast and Australian Open in Sydney to Thomas / Uber Cup Finals in Thailand and Yonex All England.

There also have been some significant development activities, with an umpiring course and a line judging course completed during the year. Paul Garvey and Eva Wu have achieved their BA Accreditation as nationally qualified umpires, while young Matthew Cunningham, Dawson Lawrence and Shakthi Angusamy became Bronze Junior Umpires.

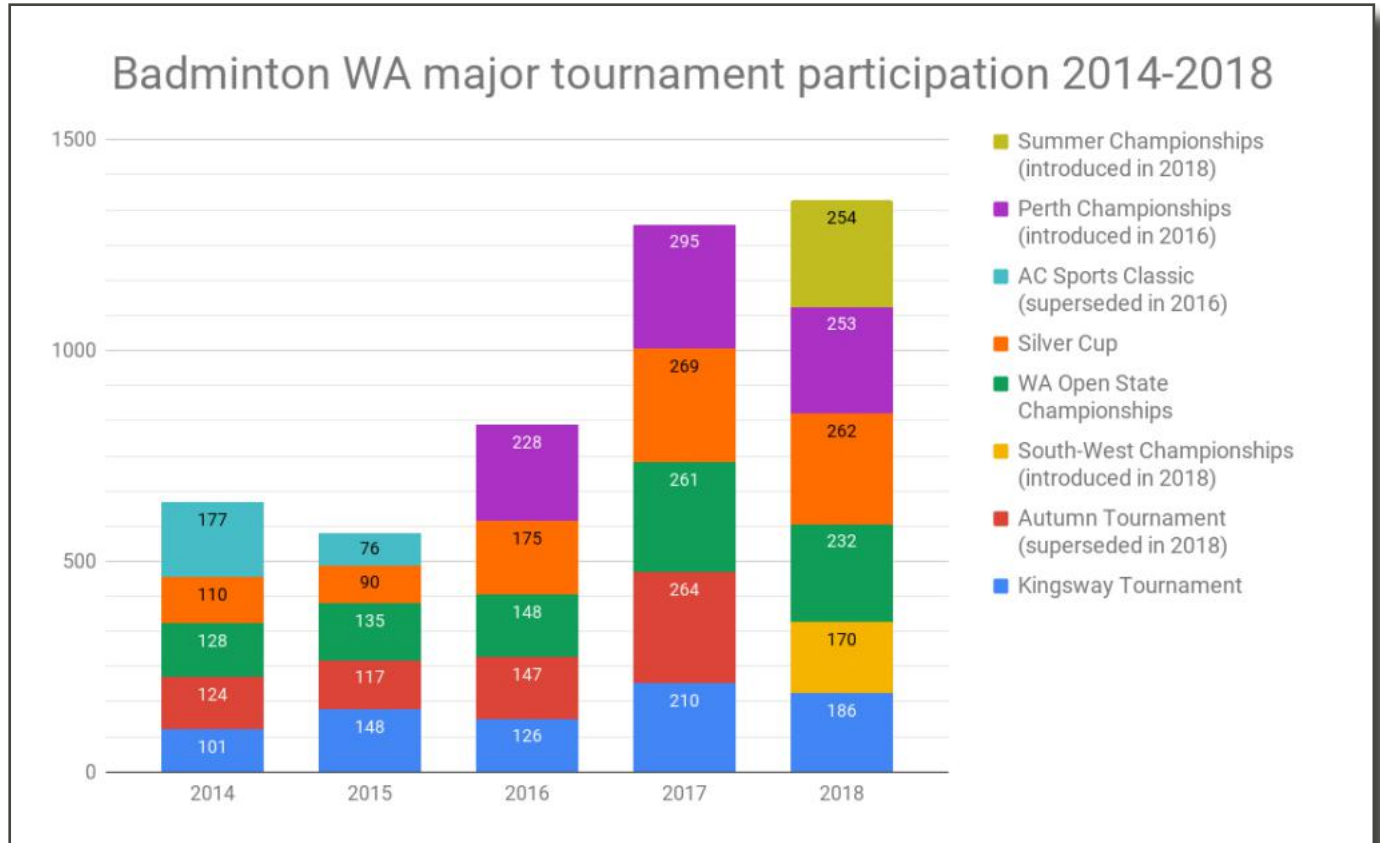
Events and Tournaments

The 2018 events calendar has been much busier than before, making it an exciting year for competitive badminton. Participation remained strong, and while the recent record player numbers per tournament haven't been exceeded, overall the total number of players across all tournaments continues to grow.

2 New Junior events (LiveLighter Junior Medallion Challenge in February, and LiveLighter Junior Closed State Championships in October) have been added to our tournament programme, as well as 1 new Senior event (LiveLighter South-West Championships held in Mandurah in April).

The WA Open Premier State Championships held on 21-22 July 2018 was the showcase event and offered prize money of \$15,000 in the Open division. Although we had hoped to attract more international and interstate players than actually entered, the standard of players that did enter was very high and made for a good entertaining event.

Our events programme continued to be supported by Our Naming Rights Partner Healthway promoting the LiveLighter message. Our new joint initiative was a LiveLighter Recipe contest, and 6 active and health-aware competition players have won gift vouchers.

Australian Junior International and Asia-Pacific U19 Team Championships

On 11-16 September 2018 Badminton WA hosted two international junior events:

- * Asia-Pacific Under 19 Team Championships (sanctioned by Badminton Oceania, based on the mixed team format was previously known / held as Pan-Pacific Trophy)
- * Australian Junior International (sanctioned by the Badminton World Federation).

Both events were supported by Badminton Oceania and Badminton Australia as well as the City of Wanneroo. The Referee was Jane Wheatley; Event Director Trevor Briedis.

It was anticipated that these tournaments would attract strong international entries from countries looking to offer their upcoming juniors international competition experience. Unfortunately, this was not what happened, and the event was significantly smaller than anticipated. Only 4 teams (2 * Australian & 2 * New Zealand) have entered the Asia-Pacific event, and the Australian Junior International had only 42 entries (32 from Australia, 8 from New Zealand, 1 from Malaysia and 1 from USA).

The factors contributing to such disappointingly low entries included an unfortunate "force majeure" date clash with another international event in South Australia, effect of school holidays / exam dates in a number of potentially participating countries, and less than ideal promotion strategy for the event. These will be the lessons learned and mistakes to be avoided for the future.

Despite only a modest number of players, the standard of play was excellent and the finals were attended by a number of dignitaries, including BWF Vice-President and BA President Geraldine Brown, Mayor of the City of Wanneroo Tracey Roberts, MLA for Girrawheen Margaret Quirk, City of Wanneroo Councillor Hugh Nguyen and Badminton WA Life Members. The overall presentation of the event was at a very high level and received many compliments.

It was exciting to be able to stage the inaugural LiveLighter South-West Championships at the new Mandurah Aquatic and Recreation Centre in April 2018. It is, however, encouraging to see that the sporting scene in WA is not stagnant, and there is interest in developing the sports' infrastructure.

One of our significant developments in 2018 was the new live streaming setup which has allowed a much better coverage of our tournaments on Badminton WA's YouTube channel. With integrated live score panel and graphics, we are now able to produce live video streams at quality level on par with some of the professional video companies at a fraction of a cost. Our website remains a source of information about our events and programmes, and we find that an increasing number of people turn to it to find out about our affiliated clubs and associations, tournaments, coaching options etc. Our Facebook page remains popular (despite less than desirable update frequency), and has just reached 2000 followers. Utilising modern online tools and communication technologies allows us to be closer to our members and the badminton community, although we are still very far from perfect.

Success of our programmes and initiatives creates an excellent platform for partnering with a variety of businesses, building much needed ties and support networks. In the current economic climate this remains difficult, and our efforts are not always sufficient. We would like to ask our members who come from a variety of backgrounds and organisations to help us build a better future for badminton in WA.

TREASURER'S REPORT



It is with mixed feelings, I present Badminton WA's audited financial statements for the year ending 31st December 2018.

Operating Results

The Association recorded a small net operating deficit of approximately \$5K in the 2018 financial year. Key items which I wish to comment on are:

1. A significant item in this year's financial statements is a reduction in the net opening equity (or accumulated surpluses / net assets) in an amount of \$37.5K. This was due to an accounting error from quite a few years ago, before the current Executive Officer's and my own tenures. This error was only identified during the 2018 year. The reduction corrects for a prior period error in the preparation of earlier years' audited accounts, and does not constitute part of a true reported operating result for the 2018 year according to Accounting Standards, and as compared to our budget for 2018.
2. The participation funding grant from Badminton Australia was unexpectedly reduced by \$6K.
3. We did not receive any inclusivity funding which was a further \$6.2K reduction.
4. A portion (\$4.2K) of a government grant received had to be returned. This happened because, due to a number of

challenges and limitations, we were unable to deliver some of the aspects a planned development program for state team coaches and managers.

5. To handle the Association's increased workload we had to increase the expenditure on staffing costs by approximately \$4.9K.

Overall, just in grants alone the real variance between this year and last year was approximately \$43.8K. For an association of our size, we were very fortunate that other aspects such as Wings and Tournaments were able to supplement our income and reduce the overall impact in real terms. This result demonstrates that the Association continues to operate in a fiscally responsible manner and is able to manage challenging financial circumstances.

Since we have slipped back into a small operating deficit position, the Board of Management has had to make some difficult decisions to bring the budget back into neutral or ideally positive territory. Since grants have proved to have a high degree of variability, getting into a financially self-sustaining position continues to be a very important priority for the Association.

Balance Sheet

Badminton WA continues to be in a strong financial position with approximately \$312K in net equity (or accumulated surpluses / net assets) as at 31st December 2018. Unfortunately, this is a reduction of approximately \$40K from the 2017 position due to the combination of this year's small operating deficit and the prior period error accounting adjustment as explained above (1) and in the notes to the accounts. The Association's cash continues to be managed conservatively with \$200K held in a term deposit and a further \$96K in an interest bearing account.

The Association continues to be run in line with the strategies and plans developed by the Board of Management and endorsed by the membership. The strategic plan has been refreshed and revitalised and endorsed by the members at the 2018 AGM. In financial terms, the strategic alignment is reflected by the majority of funds expended on tournaments, state teams and high-performance squads, school coaching and events and Wings Junior clubs. Much of this is focussed on increasing grassroots participation to continue to lay the foundations for a sustainable association. The second largest outlay is for staffing and is likely to continue and might even need to increase in the future given the complexity and volume of work required to operationally and strategically support the Association. By my

assessment, this level of staffing needs to continue to be supported financially however this large single outlay (outside of normal running costs) will need to continue to be managed both from a workload and a financial perspective. The staffing outlay is considered justified, necessary, and highly valued.

Audit Findings

Badminton WA has once again engaged the services of Violette Schreiber, the same auditor we have appointed for the last three years.

There were no adverse audit findings by the auditor and in fact, she commended the Association on our internal control processes.

General Comments

Sincere thanks go to our Executive Officer and Administrative Assistant who carry out the majority of operational duties and make my role significantly easier than it could be.

My thanks to the Board of Management for their tireless efforts to maintain and improve the operation and management of this great sport in Western Australia.

I commend the 2018 annual accounts for your acceptance.

Notes to the Financial Statements

For the year ended 31 December 2018

Note 1: Summary of Significant Accounting Policies

The financial statements are prepared on the basis that The Badminton Association of Western Australia (Inc.) (the "Association") is a non-reporting entity. The financial report is therefore a special purpose financial report that has been prepared in order to meet the requirements of the Association's Constitution, Australian Accounting Standards and other authoritative pronouncements of the Australian Accounting Standards Board.

The financial report has been prepared in accordance with the following Australian Accounting Standards and Interpretations and the disclosure requirements:

- AASB 101, Presentation of Financial Statements
- AASB 108, Accounting Policies, Changes in Accounting Estimates and Errors
- AASB 1031, Materiality
- AASB 1048, Interpretation of Standards
- AASB 1054, Australian Additional Disclosures.

The financial report covers The Badminton Association of Western Australia (Inc.) as an individual entity. The Badminton Association of Western Australia (Inc.) is incorporated in and domiciled in Western Australia under the State's Associations Incorporation Act 2015.

The financial report has been prepared on an accruals basis on historic costs and does not take into account changing money values or, except where stated, current valuations of non-current assets. Cost is based on the fair values of the consideration given in exchange for assets.

The following is a summary of the significant accounting policies adopted by the Association in the preparation of the financial report. The accounting policies have been consistently applied unless otherwise stated.

Property, plant & equipment

The Association's fixed assets are office & other equipment and are brought to account at cost, less where applicable, any accumulated depreciation or amortisation.

The depreciable amount of all fixed assets is depreciated on a straight-line basis over their useful lives to the Association commencing from the time the asset is held ready for use.

The depreciation rates used for each class of depreciable asset are:

Class of Asset: Office equipment, Depreciation rate: 20%

Class of Asset: Other equipment, Depreciation rate: 20%

Income tax

The Association is exempt from payment of income tax under Subdivision 50-B of the Income Tax Assessment Act 1997.

Employee entitlements

Provision is made for the liability for employee entitlements on the following basis:

- Annual leave - statutory or contracted entitlement is provided for;
 - Long service leave - statutory or contracted entitlement is provided for;
- As at 31 December 2018, there was no liability for unused annual leave and there was no long service leave liability.
- Sick or other leave - there are no sick or other leave entitlements that accrued as a monetary entitlement and therefore no provision has been established.
 - Contributions required under the Superannuation Guarantee legislation are charged as expenses when incurred and remitted to the employees' nominated fund accounts as required by law.

Revenue

A number of the Association's programs are supported by grants received from the federal, state and local governments.

If conditions are attached to a grant, which must be satisfied before the Association is eligible to receive the contribution, recognition of the grant as revenue is deferred until those conditions are satisfied.

Revenue from the sales of goods is recognized upon the delivery of goods to customers.

Revenue from the rendering of a service is recognized when the amount of revenue can be measured reliably, collection is probable, the costs incurred or to be incurred can be measured reliably, and when the criteria for each of the Association's different activities have been met.

Interest revenue is recognized on a proportional basis taking into account the interest rates applicable to the financial assets.

All revenue is stated net of the amount of goods and services tax (GST).

Cash

For the purpose of the statement of cash flows, cash includes cash on hand and at call deposits with banks or financial institutions.

Notes 6: Grant revenue

In regard to the OSP grant, a prior period error in past audited accounts has been identified. Historically, OSP (Organisational Sustainability) grants had always been for the financial year 1 July to 30 June, and at balance date the Association would treat for its financial year ended 31 December only 50% of the annual grant to be earned revenue and the remaining 50% to be deferred or unearned income (credit balance = liability) in the Balance Sheet. Current year investigations have revealed that at some point in the last 4 or so years, the term of the grant has been varied by the Department to our own financial (=calendar) year. Accordingly in 2018 only \$37,500 net has been able to have been recognised to be earned revenue, even though the level of the grant has been maintained consistently at \$75,000pa in recent years.
